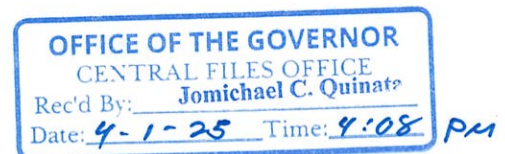

**AN ACT TO APPROPRIATE FIVE MILLION SEVEN HUNDRED FIFTY THOUSAND NINE HUNDRED EIGHTY-FOUR DOLLARS (\$5,750,984) FROM THE FISCAL YEAR 2025 GENERAL FUND REVENUES COLLECTED IN EXCESS OF THE ADOPTED LEVELS ENUMERATED IN PUBLIC LAW 37-125 TO THE UNIVERSITY OF GUAM FOR THE PURPOSE OF REPAIRS, MAINTENANCE, CAPITAL IMPROVEMENT PROJECTS AND ACCREDITATION RELATED PRIORITIES.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Appropriation.** Notwithstanding any other provision of law, the  
3 sum of Five Million Seven Hundred Fifty Thousand Nine Hundred Eighty-four



1 Dollars (**\$5,750,984**) is hereby appropriated from the Fiscal Year 2025 General Fund  
2 revenues collected in excess of the adopted levels enumerated in Public Law 37-125  
3 to the University of Guam for the purpose of repairs, maintenance, capital  
4 improvement projects, and accreditation related priorities. The funds appropriated  
5 herein shall be available for expenditure only until the end of Fiscal Year 2025. Any  
6 unexpended funds remaining after September 30, 2025, shall revert to the General  
7 Fund. The funds allocated and authorized in this Section are not subject to *I*  
8 *Maga'hågan/Maga'låhen Guåhan*'s transfer authority.

9 **Section 2. Unauthorized Use.** The funds appropriated herein shall not be  
10 used for any salary raises or the creation of new positions.

11 **Section 3. No Increase in Tuition or Student Fees.** Notwithstanding any  
12 other provision of law, rule or regulation, policy, or procedure, the University of  
13 Guam shall not impose any increase in tuition, mandatory student fees, or other  
14 student-related fees for a period of one (1) year from the enactment of this Act if  
15 such an increase is justified by salary adjustments, operational expenses, or capital  
16 improvement projects funded by this appropriation. Any other proposed tuition or  
17 fee increase within this period shall be reported to and reviewed by *I Liheslaturan*  
18 *Guåhan* no later than sixty (60) days prior to the date of its implementation. The  
19 University of Guam shall submit a detailed financial justification demonstrating such  
20 an increase is unrelated to this appropriation. The University of Guam shall certify  
21 compliance with this provision in its annual financial report to *I Liheslaturan*  
22 *Guåhan*. Failure to comply with this provision shall result in a legislative review of  
23 the University's tuition and fee structure, and any subsequent tuition or fee increase  
24 within the next three (3) fiscal years shall require prior approval by *I Liheslaturan*  
25 *Guåhan*.

26 **Section 4. Effective Date.** This Act shall be effective upon enactment.
