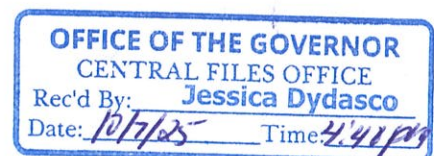

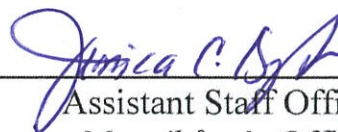

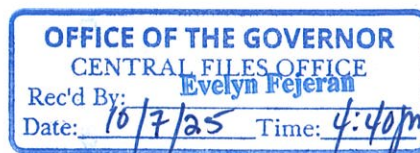

**AN ACT TO *ADD* A NEW § 25.50 TO CHAPTER 25, AND
A NEW § 19.82 TO CHAPTER 19, BOTH OF TITLE 9,
GUAM CODE ANNOTATED, RELATIVE TO THE
DEFINITION AND INCLUSION OF INTERFERING
WITH THE REPORTING OF CRIMINAL SEXUAL
CONDUCT OFFENSES.**

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. A new § 25.50 is *added* to Chapter 25, Title 9, Guam Code
Annotated, to read:

**“§ 25.50. Interfering with the Reporting of Criminal Sexual
Conduct.**

1 (a) Any person commits the crime of interfering with the
2 reporting of criminal sexual conduct if the person:

3 (1) commits any act of criminal sexual conduct or
4 assists in or abets any act of criminal sexual conduct, as
5 enumerated in this Chapter and

6 (2) intentionally, knowingly, or recklessly prevents or
7 attempts, either directly or through other persons, to prevent the
8 victim of or a witness to that act of criminal sexual conduct from
9 calling a 911 emergency communication system, obtaining
10 medical assistance, or making a report to any law enforcement
11 officer or other official.

12 (b) Commission of, or assisting in or abetting a crime of
13 criminal sexual conduct under this chapter is a necessary element of the
14 crime of interfering with the reporting of criminal sexual conduct.

15 (c) Interference with the reporting of crimes of criminal
16 sexual conduct is a felony of the third degree.”

17 **Section 2.** A new § 19.82 is *added* to Chapter 19, Title 9, Guam Code
18 Annotated, to read:

19 **“§ 19.82. Interfering with the Reporting of Criminal sexual**
20 **conduct; Defined and Punished.**

21 (a) Any person commits the crime of interfering with the
22 reporting of criminal sexual conduct if the person:

23 (1) commits an act of criminal sexual conduct or assists
24 in or abets any act of criminal sexual conduct, as enumerated in
25 Chapter 25 of this Title; and

26 (2) intentionally, knowingly, or recklessly prevents or
27 attempts, either directly or through other persons, to prevent the

1 victim of or a witness to that act of criminal sexual conduct from
2 calling a 911 emergency communication system, obtaining
3 medical assistance, or making a report to any law enforcement
4 officer or other official.

5 (b) Commission of, or assisting in or abetting a crime of
6 criminal sexual conduct under Chapter 25 of this title is a necessary
7 element of the crime of interfering with the reporting of criminal sexual
8 conduct.

9 (c) Interference with the reporting of crimes of criminal
10 sexual conduct is a felony of the third degree.”
