AN ACT TO APPROPRIATE THIRTY-FIVE THOUSAND DOLLARS (\$35,000.00) FROM THE FUNDS OF THE OFFICE OF SENATOR TELO T. TAITAGUE TO THE GUAM ANIMALS IN NEED (GAIN) TO UPGRADE DRIVEWAY REPAIRS; SECURITY CAMERAS; FENCE REPAIRS; NEW FRONT DOOR INSTALLATION, AND TYPHOON SHUTTERS AND RESOURCES NEEDED FOR THE CARE OF THE ANIMALS AT THE FACILITY.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings & intent. *I Liheslaturan Guåhan* finds that

Guam Animals In Need (GAIN) houses a large number of animals. The safety and security of the animals, staff, volunteers and customers are paramount. The clearing and grading the drive-in area and the installing of a permeable driveway will ensure a safe and reliable access at all times. The installation of a state-of-the-art security cameras will monitor all areas of the shelter providing both animal safety and safety of staff and volunteers. The repair and reinforcement of the perimeter fence will ensure that all animals are securely contained and prevent any unauthorized access. The installation of a new front door will also provide a better barrier against potential break-ins or other safety concerns. The installation of typhoon shutters will ensure that the necessary equipment and devices are kept safe and maintained.

1 It is the intent of *I Liheslatura* to appropriate Thirty-Five Thousand Dollars
2 (\$35,000.00) from the budget allotted to the Office of Senator Telo T. Taitague to
3 Guam Animals In Need (GAIN).

4 **Section 2. Appropriation:** The sum of Thirty-Five Thousand Dollars
5 (\$35,000.00) is hereby appropriated from the budget allotted to the Office of Senator
6 Telo T. Taitague by *I Liheslaturan Guåhan* to Guam Animals In Need (GAIN) for
7 the purpose of driveway repairs, upgrading security cameras, repairing fences, new
8 front door installation, installation of typhoon shutters, and resources needed for the
9 care of the animals at the facility.

10 Notwithstanding any other law or rule, the Fiscal Officer of *I Liheslatura* is
11 authorized to reduce the allotment to the budget allotted to the Office of Senator Telo
12 T. Taitague by an amount equal to the sum appropriated by this section.

13 **Section 3. Severability.** If any provision of this Act or its application to any
14 person or circumstance is found to be invalid or inorganic, such invalidity shall not
15 affect other provisions or applications of this Act that can be given effect without
16 the invalid provision or application, and to this end the provisions of this Act are
17 severable.

18 **Section 4. Effective Date.** This Act shall be effective upon enactment.
