**AN ACT TO DEAPPROPRIATE FORTY-TWO THOUSAND DOLLARS (\$42,000.00) FROM THE FUNDS OF THE OFFICE OF SENATOR TELO T. TAITAGUE AND TO REAPPROPRIATE SAID SUM TO THE DEPARTMENT OF PARKS AND RECREATION'S PARK POLICE SECTION.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings & intent.** *I Liheslaturan Guåhan* finds that  
3 the Department of Parks and Recreation's Park Police Section is in need of additional  
4 CCTV System, on and off-road motorcycles, portable generator, and traffic cones  
5 with reflective collars.

6 It is the intent of *I Liheslatura* to deappropriate Forty-two Thousand Dollars  
7 (\$42,000.00) from the budget allotted to the Office of Senator Telo T. Taitague and  
8 to reappropriate said sums to the Department of Parks and Recreation's Park Patrol  
9 Division.

10 **Section 2. Deappropriation and Reappropriation:** The sum of Forty-two  
11 Thousand Dollars (\$42,000.00) is hereby deappropriated from the sums appropriated  
12 to *I Liheslaturan Guåhan* and reappropriated to the Department of Park and  
13 Recreations' Park Police Section for the purchase of an additional CCTV System,

1 on and off-road motorcycles, portable generator, and traffic cones with reflective  
2 collars. This reappropriation shall continue until fully expended

3 Notwithstanding any other law or rule, the Fiscal Officer of *I Liheslatura* is  
4 authorized to reduce the allotment to Senator Telo T. Taitague's Office by an amount  
5 equal to the sum deappropriated by this section.
