AN ACT TO DEAPPROPRIATE FORTY-TWO THOUSAND DOLLARS (\$42,000.00) FROM THE FUNDS OF THE OFFICE OF SENATOR TELO T. TAITAGUE AND TO REAPPROPRIATE SAID SUM TO THE DEPARTMENT OF AGRICULTURE'S LAW ENFORCEMENT SECTION'S CONSERVATION CORPS APPRENTICE PROGRAM.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings & intent. *I Liheslaturan Guåhan* finds that the Department of Agriculture Law Enforcement Section's Conservation Corps Apprenticeship Program in need of additional vest for the Apprentice Program; Body Armor, uniform accessories such as belts, pouches and patches. *I Liheslatura* further finds that they also need additional ammunitions for use at the firing range.

It is the intent of *I Liheslatura* to deappropriate Forty-two Thousand Dollars (\$42,000.00) from the budget allotted to the Office of Senator Telo T. Taitague and to reappropriate said sums to the Department of Agriculture's Conservation Corps Apprentice Program.

Section 2. Deappropriation and Reappropriation. The sum of Forty-two Thousand Dollars (\$42,000.00) is hereby deappropriated from the sums appropriated to *I Liheslaturan Guåhan* and reappropriated to the Department of Agriculture

1 Conservation Corps Apprentice Program for the purpose of purchasing additional
2 vest for the Apprentice Program; body armor; uniform accessories such as belts,
3 pouches and patches; additional ammunitions for use at the firing range. This
4 reappropriation shall continue until fully expended.

5 Notwithstanding any other law or rule, the Fiscal Officer of *I Liheslatura* is
6 authorized to reduce the allotment to Senator Telo T. Taitague by an amount equal
7 to the sum deappropriated by this section.
