AN ACT TO APPROPRIATE FROM THE GENERAL FUND UNAPPROPRIATED BALANCE AS OF SEPTEMBER 30, 2025 TWO MILLION NINE HUNDRED TWELVE THOUSAND EIGHTY-SIX DOLLARS (\$2,912,086) TO GBHWC FOR THE INTENSIVE PSYCHIATRIC TREATMENT STABILIZATION 24-HOUR THERAPEUTIC GROUP HOME FOR CHILDREN AND ADOLESCENTS WITH SERIOUS EMOTIONAL DISTURBANCE AND NINE HUNDRED FORTY-SEVEN THOUSAND TWO HUNDRED FORTY-NINE DOLLARS (\$947,249) TO DOA FOR RESIDENTIAL TREATMENT FUND.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Appropriation to GBHWC for Therapeutic Group Home.**

3 Notwithstanding any other provision of law, the sum of Two Million Nine Hundred
4 Twelve Thousand Eighty-Six Dollars (\$2,912,086) is appropriated from the General
5 Fund unappropriated balance as of September 30, 2025 to the Guam Behavioral
6 Health and Wellness Center (GBHWC) for the Intensive Psychiatric Treatment
7 Stabilization 24-hour Therapeutic Group Home for Children and Adolescents with
8 Serious Emotional Disturbance.

1 **Section 2. Supplemental Appropriation to DOA for Residential**
2 **Treatment Fund for FY2026.** Notwithstanding any other provision of law, for
3 Fiscal Year 2026, the sum of Nine Hundred Forty-Seven Thousand Two Hundred
4 Forty-Nine Dollars (\$947,249) is appropriated from the General Fund
5 unappropriated balance as of September 30, 2025 to the Department of
6 Administration (DOA) to pay the expenses of persons under the jurisdiction of the
7 Superior Court of Guam who require residential care because of physical, mental *or*
8 emotional disabilities *or* severe emotional disturbances. The Director of DOA *shall*
9 submit reports to *I Maga'hågan Guåhan* and the Speaker of *I Liheslaturan Guåhan*
10 describing all expenditures made pursuant to this and previous appropriations no
11 *later than* thirty (30) days after the end of each quarter of Fiscal Year 2026 and post
12 the same on the DOA website.

13 **Section 3. Severability.** If any provision of this Act or its application to any
14 person or circumstance is found to be invalid or inorganic, such invalidity shall not
15 affect other provisions or application, and to this end the provisions of this Act are
16 severable.

17 **Section 4. Effective Date.** This Act shall be effective upon enactment.
