AN ACT TO APPROPRIATE THIRTY-NINE THOUSAND DOLLARS (\$39,000.00) FROM THE FUNDS OF THE OFFICE OF SENATOR TELO T. TAITAGUE TO THE DEPARTMENT OF PUBLIC HEALTH AND SOCIAL SERVICES, FOSTER CARE DIVISION TO PROVIDE NEEDED SUPPORT AND SUPPLIES TO FOSTER CHILDREN.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings & intent.

I Liheslaturan Guåhan finds that the Department of Public Health and Social Services, Foster Care Division serving Guam's foster children, is in need of additional financial support for the proper care of foster children being assisted by the Foster Care Division.

Therefore, it is the intent of *I Liheslaturan Guåhan* to appropriate Thirty-nine Thousand Dollars (\$39,000.00) from the budget allotted to the Office of Senator Telo T. Taitague to the Department of Public Health and Social Services, Foster Care Division.

Section 2. Appropriation: The sum of Thirty-nine Thousand Dollars (\$39,000.00) is hereby appropriated from the budget allotted to the Office of Senator

1 Telo T. Taitague by *I Liheslaturan Guåhan* to the Department of Public Health and
2 Social Services, Foster Care Division for the purchase of food, health hygiene
3 supplies, school supplies, and clothing needed by the Foster children. This
4 reappropriation shall be in effect until fully expended.

5 Notwithstanding any other law or rule, the Fiscal Officer of *I Liheslatura* is
6 authorized to reduce the allotment to the budget allotted to the Office of Senator Telo
7 T. Taitague by an amount equal to the sum appropriated by this section.

8 **Section 3. Severability.** If any provision of this Act or its application to any
9 person or circumstance is found to be invalid or inorganic, such invalidity shall not
10 affect other provisions or applications of this Act that can be given effect without
11 the invalid provision or application, and to this end the provisions of this Act are
12 severable.

13 **Section 4. Effective Date.** This Act shall be effective upon enactment.
14
