I am in receipt of the attached April 21, 2025, letter of request from Senator Telo Taitague to withdraw bills as follows:

BILL No. 111-38 (COR) – Telo T. Taitague – “AN ACT TO APPROPRIATE FIFTY-FIVE THOUSAND DOLLARS (\$55,000.00) FROM THE FUNDS OF THE OFFICE OF SENATOR TELO T. TAITAGUE TO HARVEST HOUSE RESOURCE CENTER TO PROVIDE NEEDED SUPPORT AND SUPPLIES TO FOSTER CHILDREN.”

BILL No. 112-38 (COR) – Telo T. Taitague – “AN ACT TO APPROPRIATE FORTY-TWO THOUSAND DOLLARS (\$42,000.00) FROM THE FUNDS OF THE OFFICE OF SENATOR TELO T. TAITAGUE TO THE DEPARTMENT OF CORRECTIONS ADMINISTRATIVE SERVICE DIVISION.”
