2 ***GUÁHAN*:**

3 **WHEREAS**, Mighty Purple Café Açai Superfruit Supply Co. was the brainchild
4 of Roke Alcantara Jr., Randy Alcantara, Kimo Lujan, and Marvin Manibusan; and

5 **WHEREAS**, the owners envisioned a space where passion for food and
6 streetwear could blend together; and

7 **WHEREAS**, Roke began building the Mighty Purple canteen in 2015, but after
8 facing inspection issues due to size, what is now the Mighty Purple Café was built to
9 serve as a kitchen for the canteen and began serving our community in April of 2016;
10 and

11 **WHEREAS**, Mighty Purple as a Café officially opened its doors in March of
12 2017; and

13 **WHEREAS**, what was originally intended to operate solely as a traveling
14 canteen is now a thriving, established café situated in the heart of our island's capital,
15 Hagåtña; and

1 **WHEREAS**, since its debut, Mighty Purple Café has consistently served visually
2 striking açai and pitaya bowls topped with fresh fruits, handmade granola, and a
3 garnishing of freshly grated coconut, as well as fruit smoothies and li-hing mui-dusted
4 fruit bowls; and

5 **WHEREAS**, throughout its ten years of operation in Guam, Mighty Purple Café
6 has expanded its menu to include additional smoothie bowl toppings, fresh fruit
7 lemonades, a house-made calamansi tea, and a variety of li-hing mui-coated gummy
8 candies; and

9 **WHEREAS**, after noticing an uptick in customers during the lunch hours,
10 Mighty Purple Café further expanded its menu to include savory dishes such as bagels
11 and sandwiches — all products used with taro baked goods to maintain the signature
12 purple aesthetic and create a unique spin on lunchtime classics; and

13 **WHEREAS**, Mighty Purple Café now also offers an assortment of stylish
14 branded clothing items and merchandise for customers and supporters to further
15 represent their love for the café; and

16 **WHEREAS**, in 2019, Mighty Purple Café expanded its space to accommodate
17 more members of our community by renovating the café from seven hundred twenty
18 square feet (720 sq. ft.) to two thousand two hundred square feet (2,200 sq. ft.); and

19 **WHEREAS**, Mighty Purple Café has persevered alongside our local community
20 through some of the toughest times our island people have had to face, including the
21 Covid-19 Pandemic and Typhoon Mawar; and

22 **WHEREAS**, Mighty Purple Café has cultivated a community surrounding the
23 business, consisting of 15 young adults and high school students as employees, a
24 plethora of customers who consistently support Mighty Purple Café, various local artists
25 and small businesses who continue to support and visit the café, and a growing online
26 following consisting of Mighty Purple Café fans from around the world; and

27 **WHEREAS**, April 2, 2026, marks ten (10) years of Mighty Purple Café Açai
28 Superfruit Supply Co. and its services in *Guåhan*; now therefore, be it

1 **RESOLVED**, that *I Mina'trentai Ocho Na Liheslaturan Guåhan* does hereby, on
2 behalf of the people of Guam, commend Mighty Purple Café Açai Superfruit Supply
3 Co. on its Tenth (10th) Year Anniversary of dedicated service and commitment to
4 connecting our community through its food and welcoming environment; and be further

5 **RESOLVED**, that the Speaker certify, and the Legislative Secretary attest to, the
6 adoption hereof, and that copies of the same be thereafter transmitted to Roke Alcantara
