Legislative Bill No. 291-38 (COR) intends to add a new Article 4, §§ 50401 through 50406, to Chapter 50, Title 12 of the Guam Code annotated, relative to authorizing federal financing mechanisms for government development projects, to be known as the "Federal Financing Authorization Act."
