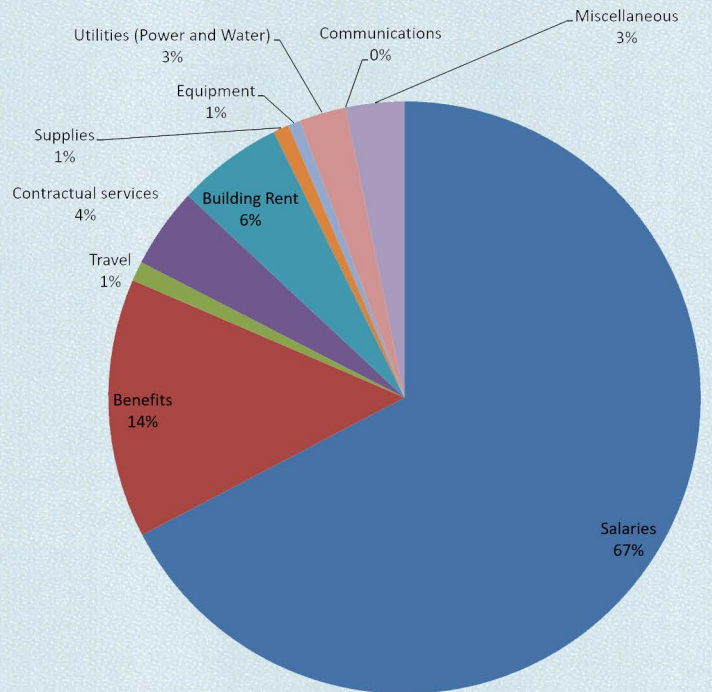

The Guam Legislature is the lawmaking body of our government and sets policy for Guam. Fifteen Senators are elected at-large by island voters and serve two-year terms.
