MINUTES

I. CALL TO ORDER

The regular meeting of the Criminal Justice Automation Commission was called to order at 10:00 a.m. by Co-Chair Associate Justice Katherine Maraman.

II. PROOF OF DUE NOTICE OF MEETING:

The publication of the five-day Notices of Meeting of the Criminal Justice Automation Commission, as required under the Open Government Law, was published in the Pacific Daily News. Proof of publication and acknowledgements are on file.

III. DETERMINATION OF QUORUM

As this was the inaugural meeting of the Commission and pending adoption of interim bylaws, Co-Chair Associate Justice Katherine A. Maraman conducted roll call and confirmed a quorum.

IV. OPENING REMARKS

Chief Justice Robert J. Torres addressed the Commission and recognized Associate Justice Katherine A. Maraman for her leadership as Co-Chair of the Criminal Justice Automation Commission. He thanked Senator E. Shawn Gumataotao for sponsoring Public Law No. 38-53, which codified the Commission. He expressed appreciation to CJAC partner agencies for their continued collaboration in strengthening the justice system and enhancing public confidence.

Senator E. Shawn Gumataotao thanked the Commission for its support and participation in the inaugural meeting. He acknowledged Jason Tedtaotao of his

office for his assistance and for working alongside the Judiciary on the legislation. He also thanked the Legislature and the Governor for enacting the public law.

VI. NEW BUSINESS

A. Adoption of Draft By-Laws

Justice Maraman stated that the Judiciary's staff attorney prepared the draft bylaws. She opened the floor for questions or proposed amendments and noted her intent to appoint a committee to draft the final bylaws. Justice Maraman called for a motion to approve the interim bylaws. Department of Corrections Director Fred Bordallo moved to adopt the interim bylaws. The motion was seconded and approved unanimously. Pursuant to the interim bylaws, the Commission established the positions of CJAC Secretary and Assistant Secretary. Justice Maraman appointed Erica Unpingco as Secretary and Shelterihna Alokoa as Assistant Secretary.

B. Selection of Meeting Dates

Justice Maraman noted that Public Law No. 38-53 requires the Commission to meet quarterly. She stated that future agendas will generally follow prior CJAC meeting formats and encouraged members to suggest agenda items. The next meeting is anticipated to take place in mid-January 2026.

C. Virtual Computerized Criminal History (VCCH) System Status

Administrator of the Courts Danielle Rosete provided an update on the Virtual Computerized Criminal History (VCCH) system, noting that it has been inoperable. The Judiciary is collaborating with the vendor, Datamaxx, to rebuild the system. Contributing entities—including the Guam Police Department (GPD), Department of Corrections (DOC), Office of the Attorney General (OAG), and the Judiciary—have made improvements to their respective case management systems. The VCCH rebuild will incorporate these enhancements to improve information sharing across the law enforcement community and with partner agencies, including the Guam Behavioral Health and Wellness Center, Department of Youth Affairs, and Department of Public Health and Social Services. Administrator Rosete emphasized that timely and accurate data is critical to community safety.

The test system has received the required Interface Control Documents (ICDs) from DOC, OAG, and the Judiciary. Administrator Rosete requested the remaining ICD from GPD to allow the rebuild to proceed, noting that the process may take several months. Administrator Rosete also described efforts to enhance data retrieval across all contributing systems and to develop system resiliency. In the event a contributing system is unavailable, data mapping will allow queries to proceed to alternate systems. She expressed appreciation for the Commission's collaboration and looks forward to continuing work to strengthen and expand CJAC initiatives.

VII. COMMUNICATIONS

There were no communications.


VIII. OPEN DISCUSSION

Justice Maraman opened the floor for discussion. Director Fred Bordallo noted gaps in data sharing, particularly between GPD and DOC. He highlighted governance and technology needs for agencies such as the Department of Agriculture's Conservation Office and other entities to ensure law enforcement data is consistent and accessible for public safety. Judiciary Deputy Marshal Joseph Leon Guerrero emphasized the importance of interagency communication and noted that he is assisting agencies, including the Department of Public Health and Social Services and the Port Authority of Guam, with NCIC data access. He stated that these efforts will continue.

IX. ADJOURNMENT

Justice Maraman announced that future meetings will be held virtually and thanked members for their participation. The meeting adjourned at 10:34 a.m.
