
**WHEREAS**, the GMHA Board of Trustees has reviewed the list of new fees and found the same to be in order; now therefore be it,



I.	Introduction	<p>Ms. Yukari Hechanova introduced herself at the public hearing as the Presiding Hearing Officer for this public hearing and announced the commencement of this public hearing at 9:00 a.m.</p>		Informational

Opening Remarks	<p>On behalf of the GMHA Board of Trustees, the Hospital Administrator/CEO, and the GMHA employees, Ms. Hechanova welcomed the public to join this public hearing via Zoom Video Conferencing.</p> <p>Ms. Hechanova indicated that we had an agenda to follow and the public would be given an opportunity to ask questions later.</p>		Informational
III.	Purpose of the Public Hearing	<p>Ms. Hechanova cited the enactment of Public Law 26-66 in December 2001, which removed the rate-setting jurisdiction from the PUC and gave it to the GMHA Board of Trustees and the Guam Code Annotated 10GCA §80109(c) that gave the authority to the Hospital to set its rates.</p> <p>In compliance with the Administrative Adjudication Law and further Guam Code Annotated directives, the Hospital published in the Guam Daily Post the announcement of this public hearing. The Hospital also posted the announcement of this public hearing on the GovGuam Public Notices Portal to notify the public.</p> <p>The Hospital also sent the notice of this public hearing via electronic mail and facsimiles to various news media organizations and via electronic mail to the Governor's Office, Lieutenant Governor's Office, the Congressman's Office, and to our elected Senators of the 38<sup>th</sup> Guam Legislature. In addition, letters were sent to the third party payers via electronic mail inviting them to join this public hearing via Zoom Video Conferencing.</p> <p>The Hospital also posted the Notice of Public Hearing and the list of new fee items on its official website as mandated by public law.</p>		Informational

Testimonies from the Public	<p>Ms. Hechanova inquired if any individual from the public who joined this public hearing would like to testify.</p> <p>She stated that the public could submit a written testimony to the Hospital Administrator/CEO within five (5) work days after this public hearing. These testimonies would be incorporated into the submission package to the Guam Legislature subsequent to the approval by the GMHA Board of Trustees.</p> <p>Mr. Frank Campiillo from Calvo's Selectcare indicated that they would submit written testimony within the five days allowed.</p> <p>For the record, there were no other response from the public to provide any testimony.</p>	Informational																		
VI.	Questions and Answers on Proposed Fees	<p>Ms. Hechanova commenced soliciting for any questions from the public who might have concerns about the fees presented at the public hearing today.</p> <p>Mr. Campillo expressed his concern on some of the fees with effective dates that were being retroactive back from July all the way to October 2025. He suggested to have those fees applied subsequent to the public hearing in order for everybody to have a chance to prepare.</p> <p>Ms. Hechanova explained that those fees were for supplies that were immediately used and charged to the patients. That is the reason why the law allows the Hospital to present interim fees. She recommended that Mr. Campillo include his comment on the effective dates in his written testimony, which would be submitted for discussion when the Legislature schedule a public hearing.</p> <p>For the record, there were no other questions from the public.</p>	Informational																		


