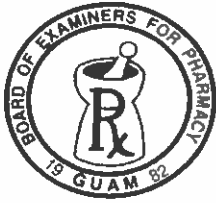

"I'm very proud of my teammates for not folding when they [the Islanders] went on a run. Our coach has prepared us since day one for tough moments like tonight's game," Ko said.

The 32-year-old retires as a Steeler and looks forward to a career in broadcasting. Wife Alex is a lead writer with CNN. They have a soon-to-be 1-year-old son Noah.


