

Taitingfong reported financial information received from the Department of Administration, stating that for fiscal year 2026 the Board was appropriated \$55,985 and allotted \$18,452, of which \$10,000 had already been expended for contractual services including website maintenance, transcription services, and required public notices, resulting in a remaining balance of \$7,547.35, with no expenditures made for travel, office needs, supplies, or equipment, aside from a \$300 miscellaneous payment identified as annual dues. It was further reported that the Board currently has an available balance of \$45,680.85, and that for fiscal year 2025 the Board generated \$83,925 in revenue, as well as an approximate \$35,000 surplus from fiscal year 2024, although uncertainty was expressed regarding where these funds are held, who controls them, and how the Board may access them, as the funds do not appear to flow directly through the reporting process.</p> <p>B. Sablan responded by clarifying that the reported revenue exceeding \$80,000 originates from the Department of Administration's financial system and is appropriated to the Department of Public Health and Social Services before being allocated to the HPLO through a revolving account, noting that while the Board does have access to the funds, there remains a discrepancy between the revenue collected and the amount appropriated or allotted for fiscal year 2026. She explained that this discrepancy is currently under review in coordination with the budget office and the Department of Administration, including verification of ledgers to confirm whether the full amount in license fees was received, and stated that an audit of the revenue accounts has been requested due to challenges associated with transitioning to a new financial system. She further provided an update on staffing concerns, indicating that although progress had been made in prior fiscal years to secure attorney positions, budget reductions in fiscal year 2026 limited current funding capacity, and even with additional revenue, funding certain positions would require cost sharing. She explained that investigator positions must be specifically created for the boards through the appropriate classification and statutory process, as existing positions cannot be repurposed, and expressed optimism that documentation submitted to the Department of Administration by the end of the month may result in progress, while acknowledging ongoing investigative responsibilities across multiple boards and the procedural requirements involved.</p> <p>N. Cepeda raised concerns regarding the availability of funds and inquired whether the Board could obtain an inspector or investigator position, emphasizing that board members do not receive formal investigative training and that investigations should be conducted by a qualified professional capable of providing informed recommendations. She further requested clarification on the status of establishing such a position and how the reported \$83,925 in revenue could be applied toward funding an investigator role.</p> <p>Dr. Balajadia responded by stating that she was uncertain whether an investigator position currently exists but reiterated that during a recent visit to the Legislature, she raised the need for legal counsel and an investigator or inspector, emphasizing that board members should not be responsible for conducting investigations. 		counsel and investigative support serving all boards under its purview, noting that recent discussions at the Legislature were met with a positive response. She further stated that the reported \$83,925 in revenue would be insufficient to fund these positions independently and reiterated her recommendation that the Legislature appropriate approximately \$350,000 to support full-time legal counsel, an investigator, and an inspector for all boards, expressing her continued commitment to pursuing the procurement of these positions to address ongoing concerns.

Sablan reported that ongoing weekly follow-ups were being conducted regarding the vacant SLP member position, and that there had been no updates or developments reported for the vacancy at that time.</p> <p>Dr. Miller inquired whether the amendments passed on December 22 had been merged by the Compiler of Laws into the existing statute to create a single, consolidated document, noting that only the signed bill reflecting the amendments was currently available and did not represent the full law. He also asked whether there was any information or timeline regarding the preparation of a complete, unified version of the law.</p> <p>Dr. Balajadia discussed the complexity of determining whether amended laws are automatically consolidated by the Compiler of Laws, noting that the current documentation reflected only amendments to specific sections rather than a fully integrated statute. Members expressed uncertainty about the Compiler of Laws' procedures for merging amendments with existing law and agreed that having a single, consolidated document would improve clarity and accessibility. B. Sablan was asked if she could follow up with the Compiler of Laws to inquire about the process and feasibility of producing an updated, unified version of the law.</p> <p>B. Sablan confirmed her ability to research the matter and to contact the Compiler of Laws, in order to follow up on the questions raised.</p> <p>Later in the meeting, C. San Nicolas revisited the earlier question of Dr. Miller regarding the Compiler of Laws and reported that a review of the relevant section affecting the dietitian article showed that the public law passed on December 22 had already been incorporated, with the most recent update reflected on the website as of December 5, 2024. C. San Nicolas and Dr. Miller discussed that the updated law could be downloaded from the Compiler of Laws website and confirmed that requested changes to the public law were already reflected within the applicable article. It was noted, however, that while some sections indicate when updates are made, the specific article reviewed did not reflect a recent update and instead listed the last change as occurring in 2015. Dr. Miller clarified navigation within the Compiler of Laws website, explaining that users must access the appropriate title and article to verify updates, and noted that individuals seeking licensure or information on scope of practice would need to reference the relevant article within the GCA portion to confirm the most current provisions.</p> <p>Dr. Balajadia noted that the same information was also available on the HPLO website under GBAHE. Clinical Supervision Qualifications (P.L. 37-142 § 0408(d)(1)):</b>  The Board was informed by Dr. Balajadia about a case involving the denial of a person’s clinical hours, with a subsequent letter submitted on October 29 requesting reconsideration. Dr. Balajadia noted concerns regarding the situation, explaining that Joleen Baza, a licensed professional counselor and director of Blue Ocean Behavioral Health, had submitted the letter on behalf of Dr. Millie Nice, whose internship hours had been denied because the supervision did not comply with the Board’s rules and regulations. Dr. Balajadia brought the matter to the Board’s attention in their capacity as the reviewer.</p> <p>N. However, all prior hours were previously voted on and not approved, and the Board clarified that this determination applies to the clinical hours being completed toward licensure.</p> <p>Dr. Balajadia mentioned that there are concerns regarding the opinion of the former supervisor, noting a potential conflict of interest as the supervisor's father is the director of Blue Ocean. N. Cepeda clarified that the supervisor in question holds a Ph.D. in Communication, not in a clinical or therapy-related field, and emphasized the importance of accurately representing this distinction. The Board agreed that it is ethically necessary to clarify that the supervisor's doctorate is in Communication, as misrepresentation could be misleading given that the individual is overseeing hours for someone pursuing clinical licensure as a therapist.</p> <p>Dr. Balajadia explained that while the supervisor holds a doctorate in Communication, she is not a clinical practitioner, and the situation is complicated by a potential conflict of interest. The supervisor, who is co-director of an agency, is approving clinical hours for Dr. Nice, who serves as director of the same agency, creating a situation that Dr. Balajadia described as ethically concerning and potentially in violation of professional guidelines. Despite references in the letter to the APA Code of Ethics, Dr. Balajadia emphasized that individuals in such positions should not have been involved in approving hours due to the conflict. The Board was informed that Dr. Nice is requesting reconsideration of the previously denied hours, but Dr. Balajadia highlighted the ethical and procedural issues underlying this request.</p> <p>N. Cepeda expressed strong concerns regarding the repeated requests for reconsideration of the denied hours, stating that it is unprofessional to persistently ask the same question in hopes of receiving a different answer. She emphasized that the Board's rules and regulations are clear and cannot be changed without legislative action, and that the Board is not in a position to disregard the law to grant such requests. N. Cepeda noted that all professionals, including Board members, are expected to follow established rules and licensure requirements, and that repeatedly seeking an exception is both unethical and inappropriate.</p> <p>Dr. Balajadia emphasized that the Board's laws and regulations align with national standards, which clearly indicate that the situation under discussion does not meet proper professional guidelines. Members discussed the issue of professional titles, noting that while the individual holds a doctorate in Communication, the title must clearly indicate the field of expertise to avoid misleading the public, and that clinical qualifications do not apply to a doctorate in Communication. It was further explained that during a previous meeting, the individual presented herself as a doctor without specifying her field, and had referenced certifications in clinical therapies, which do not align with her educational background, resulting in a complaint against a Board member for raising the issue. The Board clarified that the denial of hours is based on law and regulations requiring specific qualifications, not personal discretion, and emphasized the importance of maintaining consistent standards. It was noted that the individual appears determined to repeatedly challenge the Board's decision, which was described as bordering on harassment, and the Board reaffirmed that the prior decision stands. Members also confirmed that internships must have preapproval, and any hours completed without meeting these requirements cannot be accepted.</p> <p>The Board discussed that the initial supervisor was rejected because they did not meet the legal qualifications regarding the required number of years licensed to supervise prior to the hours being completed. It was explained that the applicant had attempted to set up multiple supervisors across different internship applications, some of whom did not meet the educational or licensing requirements as clearly outlined in law, and that this created integrity concerns regarding who was actually supervising the clinical hours. The Board emphasized that it had reviewed each situation thoroughly, identified mistakes where necessary, and corrected them, but the overarching issue remained that switching supervisors or attempting to bypass requirements raised ethical concerns, particularly regarding integrity, which is highlighted as a core APA ethical standard. The discussion underscored that the Board's responsibility is to uphold professional and legal standards, ensure proper supervision, and maintain the integrity of the licensure process, and that despite repeated requests from the applicant, the Board must adhere to its prior decisions.</p> <p>Dr. Harper raised a general concern regarding complaints brought to the Board, questioning why the involvement of a professional representative from the same field is often viewed as a conflict of interest. She emphasized that Board members are performing their duties according to the law, and that decisions must be made objectively without personal bias. While she acknowledged the value of having a third-party review, she expressed concern that requiring it in every instance undermines the professional judgment and ethical responsibility of Board</p>

Cepeda explained that the concern arose because the individual involved submitted a letter opposing any actions by Dr. Balajadia and herself due to an existing complaint. She clarified that the Board has been attempting to address the concern fairly, involving collaboration with V. Pereda to review the matter, and emphasized that the process has been managed professionally and cooperatively.</p> <p>Dr. Harper emphasized that board members should not allow themselves to be intimidated, pressured, or made to feel defensive when performing their duties. She stressed that the members are ethical professionals selected to serve on the Board, and they must carry out their responsibilities confidently and without yielding to external pressures, as succumbing could compromise the Board's ability to function effectively.</p> <p>N. Cepeda reinforced Dr. Harper's point by stating that she is firmly standing by her position because she presented it to the board and the matter has been repeatedly delayed. She emphasized that the Board's responsibility is to follow the law as written, and she encouraged everyone to read and understand the law themselves if they feel unsure, underscoring personal accountability and adherence to legal standards.</p> <p>Dr. Harper, emphasized that the core point of the letter is threefold, focusing especially on ethical behavior. She explained that ethics includes not just how professionals act, but also how they use their time and practice within the scope of their profession. Using her example, a veterinarian cannot practice chiropractic on patients—this illustrates that professional boundaries must be respected.</p> <p>She stressed that the public cannot judge the professional scope of practice for any profession, which is why the Board's role is crucial. Board members are obligated to ensure a minimum standard of care, monitor ethical behavior, and intervene proactively to prevent issues before complaints arise. Ethics, therefore, serves as a safeguard for both professional integrity and public protection.</p> <p>B. Sablan clarified that the request in question pertains to an appeal regarding the supervision hours or the qualifications of the supervisor for Dr. MillieNice, distinguishing it from a request for reconsideration. ## Dark origins

Sánta Rita-Sumai resident Onika Donawa, 38, originally from Trinidad and Tobago, attended the concert with her husband of 20 years.

She said it was "priceless," and she "wouldn't have spent Valentine's Day any other way."

"It was fantastic, amazing, energetic, vibrant, and reminds me of home. It's a great feeling, and we love to get a taste of home...from the Caribbean," Donawa said.
