Sana's term had concluded and that he would not be continuing, resulting in a vacancy and leaving the Board short of members, although three members remain necessary to establish quorum. Two nomination packets had been submitted to the Governor's Office in December, with a recent follow-up conducted. Sana's position and another seat that has been vacant for several years.</p> <p>An additional report was provided regarding a notification received by Board Inspector E. Aguon concerning the possible sale of non-U.S.-approved prescription drugs at facilities not licensed as pharmacies and therefore outside the Board's jurisdiction. The matter was brought to the attention of the Department of Public Health and the Department of Environmental Health, and a meeting was conducted with Tom Nadeau and Leilani Navarro to address the issue. During the meeting, DEH representatives outlined their ongoing enforcement efforts in coordination with the FDA and identified other products being marketed on Guam as over-the-counter medications that contain active pharmaceutical ingredients and have been flagged by the FDA as unsafe for sale. These efforts included visiting businesses to inform them of the violations and directing them to remove such products from their shelves.</p> <p>In alignment with its mandate to protect public health and safety through the regulation of pharmacy practice, the Board proposed issuing a public safety notice in collaboration with the Guam Board of Examiners for Pharmacy and DEH to warn the public about the risks and legal implications of purchasing or selling prescription medications outside of licensed pharmacies or without a valid prescription. Drafts of the public safety notice and a consent form for affected businesses were prepared, the latter requiring establishments to acknowledge applicable laws and confirm their understanding that prescription medications sourced from other countries or products containing active pharmaceutical ingredients may not be sold over the counter at unlicensed facilities. The Board discussed providing these documents to identified establishments and making the notice available to the public. It was recommended that businesses first be formally notified and educated, with repeat violations to be referred to the Office of the Attorney General. 	<p>1. CVS/Caremark OR CF #11506 (NR-PCY045) Representatives from CVS Health were present and introduced themselves as B. Convery, Senior Legal Counsel for CVS Health, and C. Renfer, Pharmacist-in-Charge of the Wilkes-Barre Mail-Order Facility in Pennsylvania and Director of Professional Practices for CVS Caremark. M. Gabriel explained that the renewal application had been tabled pending discussion regarding concerns, particularly related to a probationary action by the California Board of Pharmacy, which is scheduled to conclude on July 6, 2026. It was confirmed that while the pharmacy remains on probation, there are no limitations on dispensing medications into California, though conditions include public posting of probation status, reporting requirements, and probationary inspections.</p> <p>M. Gabriel summarized findings from the California case, noting concerns regarding early dispensing of controlled substances and prescriptions issued by physicians not licensed in California, and sought clarification on corrective measures implemented to prevent recurrence. The representatives explained that while California does not have a specific statutory early-fill limit, the company implemented system-wide safeguards establishing a seven-day “on-doorstep” standard for controlled substances, accounting for shipping time, and applied these controls broadly unless a state has more stringent requirements. They further stated that system enhancements were implemented to verify prescriber licensure in the destination state before dispensing controlled substances, including automated hard stops preventing fulfillment if appropriate state licensure is not confirmed. It was also clarified that no individual pharmacists were subject to disciplinary action in the California matter.</p> <p>The Board raised additional concerns regarding Guam law, including requirements for controlled substance registration, DEA licensure, and the seven-day dispensing rule from the date written. C. Renfer indicated she would need to review and provide data regarding whether controlled substances had been shipped to Guam, including prescriber licensure verification, dispensing dates, drug schedules, and overall volume of prescriptions. The Board requested submission of written policies and procedures detailing safeguards related to controlled substance dispensing, early refill prevention, and prescriber license verification. B. Convery clarified that the Pennsylvania facility is not currently shipping into Guam due to the pending license renewal; however, the Board requested historical data prior to the lapse for review. urgency, storming out to an 11-2 run and taking a 16-12 lead after the first quarter.

But once St. Paul settled in, the Warriors completely shifted the momentum.

Their defensive pressure forced the Friars into repeated halfcourt turnovers, allowing St. Paul to chip away and win the second quarter, 12-9, heading into halftime trailing just 25-24.

The third quarter proved decisive. St. Paul outscored FD, 17-10, sparked by an 8-0 run that forced a Friars timeout.

As players walked toward their benches, tempers briefly flared, leading to a technical foul against St. Paul, though no players were ejected.



"We came off a run before that," Aisek said. "So we kind of thought they're not used to it. They're not used to us getting the lead over them."

From there, the Warriors never looked back.

They closed the game with a dominant 23-13 fourth quarter, overwhelm-

ing the Friars on both ends to seal the 64-48 victory.

RJ William led St. Paul with 14 points on an efficient 60% shooting.

Sophomore standout Brez Cornelius added 10 points and four rebounds. Cornelius, named to the All-Island Second Team, showed poise well beyond

his age.

Climbing the coaching ladder

Concepcion started his coaching career at the same school, but it was upon the conversion from a high school to a middle school.

After a short stint in Santa Rita-Sumai, he moved a bit north where he took over the Jose Rios Middle School program. That is where he connected with good friend Bic Lagutang, and a coaching tandem would blossom from there.

The pair built the new Tiyan Titans basketball program for four years before spending the next seven years back down in Talo'fo'fo' with the Notre Dame Royals.

The step to JFK

Concepcion was a volunteer coach under previous coach Rey Serafico. This season, he was given the keys to the program. He said he knew there was something special from the get go.

"We saw the amount of talent that came out on the first day of tryouts," he remembers. "When we got to JFK, we saw the players and how much they wanted to win, so we built it within the same concepts of Candaso. The players bonded really fast. They quickly grasped the concepts we were teaching them."

Other than maximizing the talents led by Collin Rillamas and Tristan Hahn, the difference maker for the Islanders, according to their coach, was

"Bic was always a tale when we were seniors," Concepcion recalls of their high school days. "He was the only freshman to hang out with the seniors. The relationship grew and it became family. We are ninos for each other's kids."

Concepcion said Lagutang has been the perfect compliment with the extra set of eyes on parts of the head coach would probably miss.
