Confirmation of Public Notice posted on Guam Meeting Portal and published in Guam PDN: January 29, 2025 and February 3, 2026</p> <p>Election of Officers: Board members discussed whether an election of officers was necessary given that there were no new appointments to the Board. A. Lape noted that, unless any current member wished to change or step down from their position, there appeared to be no need to conduct an election. During discussion, J. Baleto inquired about efforts to recruit additional members and whether there had been any progress toward new appointments. A. Lape reported that although the Governor’s Office had previously contemplated a potential appointee, no eligible or viable candidates were currently available, as one individual who had expressed interest was ineligible due to serving on another board, and another potential candidate had a complaint filed against that person and no longer responded with interest. It was further noted for the record that both D. Calvo and A. Lape had exceeded the expiration of their second terms; however, pursuant to statutory provisions allowing members to remain in their roles until replaced, and in the absence of new appointments, resignations would result in a lack of quorum. 		1. Geri Bough – LCSW A. Lape reviewed the application of G. Bough, who is currently licensed in Indiana and is seeking licensure in Guam in order to continue providing telehealth services to a client relocating to the island. It was noted that G. Bough holds a Master of Social Work degree and submitted her transcript; however, confirmation of supervised clinical hours signed by her supervisor was not found in the application materials. K. Lee explained that her former supervisor is no longer practicing, and she had been asked to provide license verification. A. Lape clarified that, until the rules and regulations are promulgated, it does not have the authority to endorse an out-of-state license, and therefore G. Bough must independently satisfy Guam's supervised hours requirement. It was recommended that she request from the Indiana licensing board a copy of the documentation she previously submitted for her licensure, and that the board transmit the records directly to the HPLO. Aside from the missing verification of supervised hours, no other deficiencies were identified, as her clearances, transcript, and continuing education units appeared to be in order. A.
