

- **Complaints and Investigations:**

We continue to prepare all case files and will present to the Commission as we work on filling the vacant seats as well as on our new legislation enhancements to ensure we provide a clear pathway for cases going forward. We will be informing all complainants about our process as well as the 3-year statute of limitations that our current law allows for.

- **Advisory Opinions:** The Commission continues to field calls and inquiries regarding potential complaints and violations of the Ethics Code and have advise members of the community on the proper agencies to engage based on their circumstances and events as well as next steps with the Commission. I have asked our team to ensure we assist members of the community to the fullest extent possible and avoid simple referrals.

## Commission Update

- On February 12,2026 the Committee on Finance and Government Operations held a public hearing for the appointment of Ms. Genevieve P. Rapadas to the board of Commissioners for the Guam Ethics Commission.
- Pending the Legislature’s vote and confirmation, she is anticipated to be confirmed in this March Session which began on Monday March 23, 2026 and may run till the end of the week.

## Legislative and Policy Developments

- Bill 214-38 – Relative to Strengthening the independence and effectiveness of the Guam Ethics Commission.
- UPDATE: Bill 214-38 – The Legislature continues to deliberate on the Bill in this March Session which began on Monday March 23, 2026. As of March 24,2026, the senators continue to discuss and deliberate on the make-up of the board to create true independence for the Commission to act independently of political interference.

- On March 11, 2026 An evaluation committee, consisting of 2 Ethics Staff and 1 Commissioner, reviewed and provided their selection for the highest rated offeror to the Executive Director for further action.
- On March 16, 2026 A Notice of Intent to Award was sent to the highest rated offeror, and Notice of Non-Selection was sent to the other proposer. A cost proposal for the services has been submitted for review.
