Korean nursing students visit GMH via UOG's Global Learning Program

A total of 21 nursing students from Korea visited Guam Memorial Hospital as part of the University of Guam's English Adventure Program, highlighting the island's growing role in global learning, health care partnerships, and educational tourism, GMH said in a media release.

GMH welcomed seven nursing students from Dankook University and 14 from Baekseok University.

The visit provided students with an opportunity to learn about Guam's public hospital, observe the health care environment, and engage in cultural and educational exchange during their time on the island, GMH said.

"This visit reflects the kind of partnership that strengthens both health care and community connection," GMH interim Administrator and CEO Dr. Joleen M. Aguon said in a statement. "When students

UOG's English Adventure Program brings international students to Guam for immersive language learning and cultural en-

agement, while also connecting participants to community institutions that reflect the island's public service and professional sectors.

at UOG. "Through programs like English Adventure, students not only improve their language skills, but also gain insight into Guam's healthcare system and the important role GMHA plays in serving the island."

Diabetes self-care class series to start April 8 with UOG Land Grant

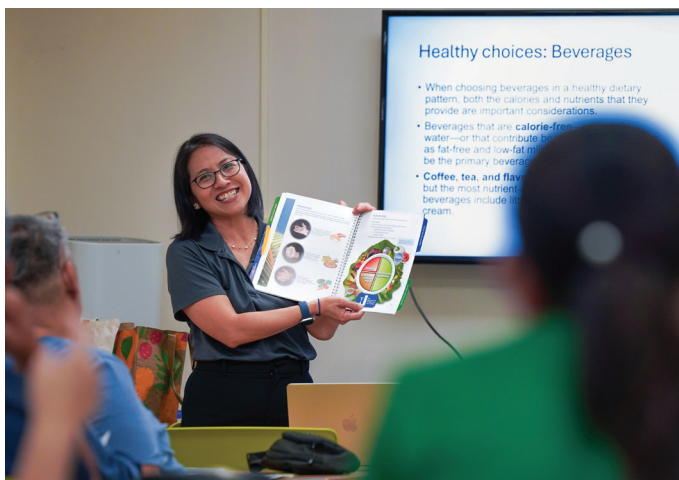

People with diabetes and their caregivers are invited to a four-session workshop on diabetes self-care with the University of Guam Land Grant Extension Service.

The Nihi ta Fanmama'tinas, or Let's Cook, Navigating Diabetes Series will be held from 3 to 5 p.m. on Wednesdays and from 9 to 11 a.m. on Saturdays from April 8 to 18 on the UOG campus, UOG said in a media release.

Participants will learn about five key areas for diabetes self-care, including:

- Understanding diabetes medication and practicing coping skills
- Learning the importance of physical activity and foot care
- Taking care of the heart and preventing long-term

- Making good food choices
- Setting goals and making small changes

Additionally, a cooking portion of each class will

provide hands-on experience making meals that follow the Diabetes Plate Method of the American Diabetes Association.

The method uses a sectioned plate as a simple tool to ensure half of

the plate is non-starchy vegetables, one-quarter is proteins, and one-quarter is carbohydrates, with no sugary beverages.

Leading the classes will be Shelly Laguana, who holds a doctorate in nutrition, and registered dietitian nutritionist Lenora Matanane, along with UOG Land Grant extension associates Clarissa Barcinas and Elaine de Leon.

Advanced registration is required, as seating is limited.

The registration fee is \$30 and covers all four sessions.

The course will be conducted over two weekends and includes six structured workshops:

Weekend 1

- Friday, April 17, 6 to 10 p.m.

- Saturday, April 18, 8 a.m. to 4 p.m.

- Sunday, April 19, 8 a.m. to 4 p.m.

Weekend 2

- Friday, June 19, 6 to 10 p.m.

- Saturday, June 20, 8 a.m. to 4 p.m.

Participants must complete 100% attendance, actively engage in both classroom and field sessions, and successfully complete a practical coaching assessment in order to receive certification.

The GFA “D” Coaching Certificate remains valid for three years, after which certified coaches must complete renewal requirements to maintain their credentials.

Eligibility, prerequisites

GFA said applicants must meet the following requirements:

- Completion of the Youth Coaching Course. Waived if registering directly for the GFA “D” course).

- Minimum age of 18 years old. 17-year-old exemptions apply to national team players or GFA Academy coaches.

- Submission of playing experience, CV.

- Demonstrated literacy; reading and writing.

- Additionally, partici-

pants must be physically and medically fit to take part in all practical sessions and are expected to demonstrate professionalism through integrity, credibility, and commitment throughout the course.

- Current or former U20 (17+) national team players with at least two years in

the program are also eligible to enroll.

Course expectations

Full attendance across all scheduled workshops is mandatory. In accordance with GFA Coach Education guidelines, failure to attend all sessions will result in ineligibility to receive certification.

No further communication or documentation was received from NACCAS or the academy indicating an intent to renew the license. D. Gurwell from Stay Fresh Academy indicated that administrative oversight, including management by R. Tingson, contributed to the lack of submission, and that efforts had been made to maintain candidate status with NACCAS. The board clarified that only one NACCAS workshop attended by the school had been documented, which had supported the temporary extension, but without submission of the formal status letter or renewal application, the school was not authorized to operate beyond the expiration date, and any student hours accrued after that time could not be recognized.</p> <p>The board emphasized that, although Stay Fresh Academy had pursued accreditation through NACCAS, the primary issue was the failure to renew the establishment license. It was explained that a school with an expired license cannot legally operate, teach, or offer services, and continuing to do so constitutes a deception of students. Additionally, the academy's sanitary permit had expired on April 30, 2025, further compounding the violation. The board stressed that because the establishment license was invalid, any student hours accrued during that period cannot be recognized, regardless of instructor presence or efforts to maintain candidate status with NACCAS. While acknowledging the students' attendance and effort, the board clarified that the hours were obtained illegally, and the responsibility for the situation rests entirely with the school's administration. Compensation for tuition might be possible, but lost instructional time cannot be recovered, and the students' hours remain invalid under board regulations.</p> <p>T. 	<p>license holder to renew their establishment license, which expires annually on December 31, and that the academy had been aware of its license expiration, including the extension to January 6, 2025. The board noted that cease and desist letters are only issued when the board becomes aware that an establishment continues to operate illegally without any instructors or oversight. It was emphasized that the situation arose solely from the school’s failure to renew its license, and the board cannot monitor or enforce renewal beyond what is reported, making the illegal operation the responsibility of the establishment, not the board. T. Flores acknowledged the explanation and thanked the board for clarifying.</p> <p>The board concluded that only student hours completed prior to the expiration of Stay Fresh Academy’s establishment license could be recognized, as any hours accrued afterward were obtained illegally and could not be honored without placing the board in legal jeopardy. It was emphasized that validating hours from an unlicensed school would set a dangerous precedent, undermining statutes designed to protect the integrity and regulation of the cosmetology industry. While acknowledging that students attended in good faith, the board clarified that the fraudulent operation of the school constitutes a violation of licensure requirements. Additionally, it was noted that the academy also operated without a valid sanitary permit, representing a separate violation under the Division of Environmental Health, meaning that instruction or services provided during that period were unauthorized and noncompliant.</p> <p>D. Gurwell provided the board with a worksheet he created to track any student hours from Stay Fresh Academy that could be transferred to Guam International Cosmetology Academy, noting that it would serve as part of the official record for accepted hours. The board confirmed that only hours accrued prior to January 6, 2025—the expiration date of Stay Fresh Academy’s establishment license—could be recognized, and any hours after that date were invalid. Regarding potential tuition compensation for students affected during the noncompliance period, D. Gurwell indicated that, to his knowledge, Stay Fresh Academy had no plans to provide reimbursement, and noted that at least one student had pursued a small claims suit against R. Tingson individually. The board clarified that compensation is a civil matter to be handled outside of board proceedings. Moving forward, the board determined that any applications submitted with transcripts from Stay Fresh Academy would receive credit only for hours completed up to January 6, 2025, calculated at an eight-hour day, five days a week. The board emphasized that operating without a valid establishment license is a misdemeanor with penalties, and while it regretted the impact on students, enforcement and</p>

Cruz, asked whether her previously earned manicuring hours from Mariacy in 2020 could be transferred to another school, such as Guam International Cosmetology Academy. The board confirmed that her manicuring hours would indeed be transferable since she had already completed that program and was licensed. It was noted that, although Mariacy is closed, the student's official transcripts could be provided by the board to facilitate the transfer. A. Taitano-Sablan advised that her remaining program at Guam International Cosmetology Academy should focus on the hair and skin components of cosmetology, as her manicuring and sanitation hours had already been satisfied, ensuring her continued training aligns with the full cosmetology curriculum.</p> <p>The board clarified on D. Gurwell's question about hours. A. Taitano-Sablan explained that if a student had completed a 400-hour manicuring program, those hours would be fully credited toward their training, and the remaining 1,200 hours required for a full cosmetology program would need to be completed at the new school.
