

thon, though not the first race he competed in the region.

In March, he ran the Skechers Saipan Marathon 2026, also finishing first with a time of 2:45:53.

Nakajima told the Pacific Daily News that the round trip from Tumon to Adelup is a series of uphill and downhill runs made more difficult given that he's pushing an occupied stroller the whole 13.1-mile course.

"[It's] a very tough course, especially with a stroller," he said.

The father said he always runs with his baby and his

wife Tomomi, 36.

Tomomi was the first female finisher of the Ko'ko' Half Marathon and finished seventh overall.

"I train hard with my baby, so I want to become a champion with my baby someday," he said. "Today my dream came true."

Following about a minute and a half behind Nakajima was fellow Japanese runner Shohei Miyamoto, at 1:18:42.

### Mandell, first Guamanian half-marathon finisher

Local middle-distance runner and long-time Ko'ko' Road Race veteran Derek Mandell was the first Guamanian to cross the finish line Sunday morning.

Mandell finished third, about two minutes behind Miyamoto, with a time of 1:20:28.

He said this was four minutes faster than his run last year.

On being the top Guam finisher, he said he felt good, adding that the competition this year from off-island competitors was very strong.

"I was happy to finish amongst them," he said.

He said he faced some "pretty decent headwind"

just after the turnaround, coming back onto Marine Corps Drive, though it provided a bit of cooling to curb the humidity.

"People are really excited to run, and they'll find a way to get their run in before they got to do their preparations," he said. "It's fun to see that, but at the same time after this, I think

we're all going to be prepping our houses and everything."


