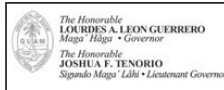

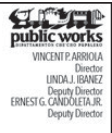

IV. APPROVAL OF AGENDA ITEMS

Chairman Gayle stated that for this particular Board meeting, he would like to table several items on the agenda in order to move forward to the Executive Session, which will focus mainly



on the upcoming Global Mediation on the contractor lawsuit. First item tabled was the Receiver Reports, in which Chairman Gayle received word from Representative Gersham that the Receivers will not be presenting this meeting, as they are preparing for the mediation. However, he did recommend that the members review the report of the Receiver that Attorney Taitano submitted to the court; which was the annual report for 2025. Next, Chairman Gayle reported that General Manager Slike prepared the Operational Update and will go through it. As it is too early in the month, Comptroller Kakigi will not be presenting the Financial Updates, but will prepare and present the updates for both March and April to discuss in April's Board meeting. The Legal Counsel's Report will be included in the Executive Session, and Chairman Gayle requested Attorney Taitano and General Manager Slike to walk them through the expectations of the mediation. Chairman Gayle then proceeded to table both the Committee Reports and the Unfinished Business. Once Executive Session resumes back to General Session, they will finish the rest of the meeting. He asked the members of the Board if they had any comment or objection to which there was none. First motion to approve the changes to the agenda was made by Vice Chair Hemlani, and second by Secretary Denney. Motion was passed unanimously.

V. APPROVAL OF MINUTES

Chairman Gayle inquired if the Board members had reviewed the minutes. Secretary Denney confirmed that she had reviewed the minutes and had no objections. Secretary Denney made the motion to approve the minutes, then seconded by Member Montellano. The motion passed unanimously and the minutes were approved.

i. OPERATIONAL UPDATE

General Manager Slike updated the members that he, along with Secretary Denney, and a group from the University of Guam and Mr. Rubbishman met on March 13, 2026 to start the work toward developing a program for sustained community outreach for educating the public on acceptable materials to place in curbside recycling bins. UOG will draft a proposal for the educational program, Guahan Waste will finalize the one-year pilot program, and GSWA will develop customer delivery and performance programs. General Manager Slike concluded that UOG will provide the budget for community outreach and advertising, however they are still trying to find funding for it.



Next, the manufacturer installers arrived on island and began installing the biodiesel conversion equipment, which will finish soon. The batch operation and training for the staff will start the following week. General Manager Slike went to congratulate and give his thanks to SWM Superintendent Perez, Engineering Supervisor Galiza, Chief of Administration Fejeran, and Administrative Officer Martinez for being instrumental in both the project and staffing at the Layon Landfill, explaining that GSWA would not have gone this far without their patience and hard work.

Then, he informed the members that included in the Board packet was the finalization of The National Laboratory of the Rockies Report on Feasibility of Waste-to-Energy on Guam, for review and discussion in future Board meetings.

Finally, General Manager Slike concluded by reporting no changes in the straw plan and that nine trucks are in operation, with three in repair. He also hopes to establish a total of fourteen permanent GovGuam employees to be stationed at the Layon Landfill.

The Performance Indicators Report was presented by Chief of Administration Fejeran who reported that for the month of February, the phone answer rate remained at 38%, which is consistent with the prior months. The phone switch issue was resolved, decreasing the number of calls received, as majority of the calls in the previous months was due to customer call backs due to dropped calls. In regards to the staffing levels, Chief of Administration Fejeran reported one representative was out for the month, and one newly hired representative was still in training, not fully contributing to the call volume. She also stated that with the addition of the two new customer service representatives, GSWA expects to see improvements as they become fully trained.

ii. FINANCIAL REPORT

Tabled.

c. LEGAL COUNSEL'S REPORT

The Legal Counsel's Report will be included with the Executive Session, however, Chairman Gayle requested Attorney Taitano to explain to the Board, and others in attendance on the rules of the Executive Session. Attorney Taitano went on to explain that because of the ongoing litigation matter surrounding the upcoming mediation, this discussion qualifies for an Executive Session. The Executive Session will consist of the Board members, GSWA's General Manager, essential GSWA



employees, and Attorney Taitano, who will represent the legal counsel. All other attendees will be placed in a waiting room until the Executive session ends, and General Session resumes. If in the event a vote is needed, they will move back into General Session to discuss, then head back into Executive Session. Though the recordings from the Executive Session will be retained, the livestream will be disconnected until General Session resumes. Chairman Gayle then asked the members of the Board who would like to make the motion to move into the Executive Session, which was made by Vice Chair Hemlani and seconded by Secretary Denney. The motion was passed unanimously, and the Executive Session commenced.

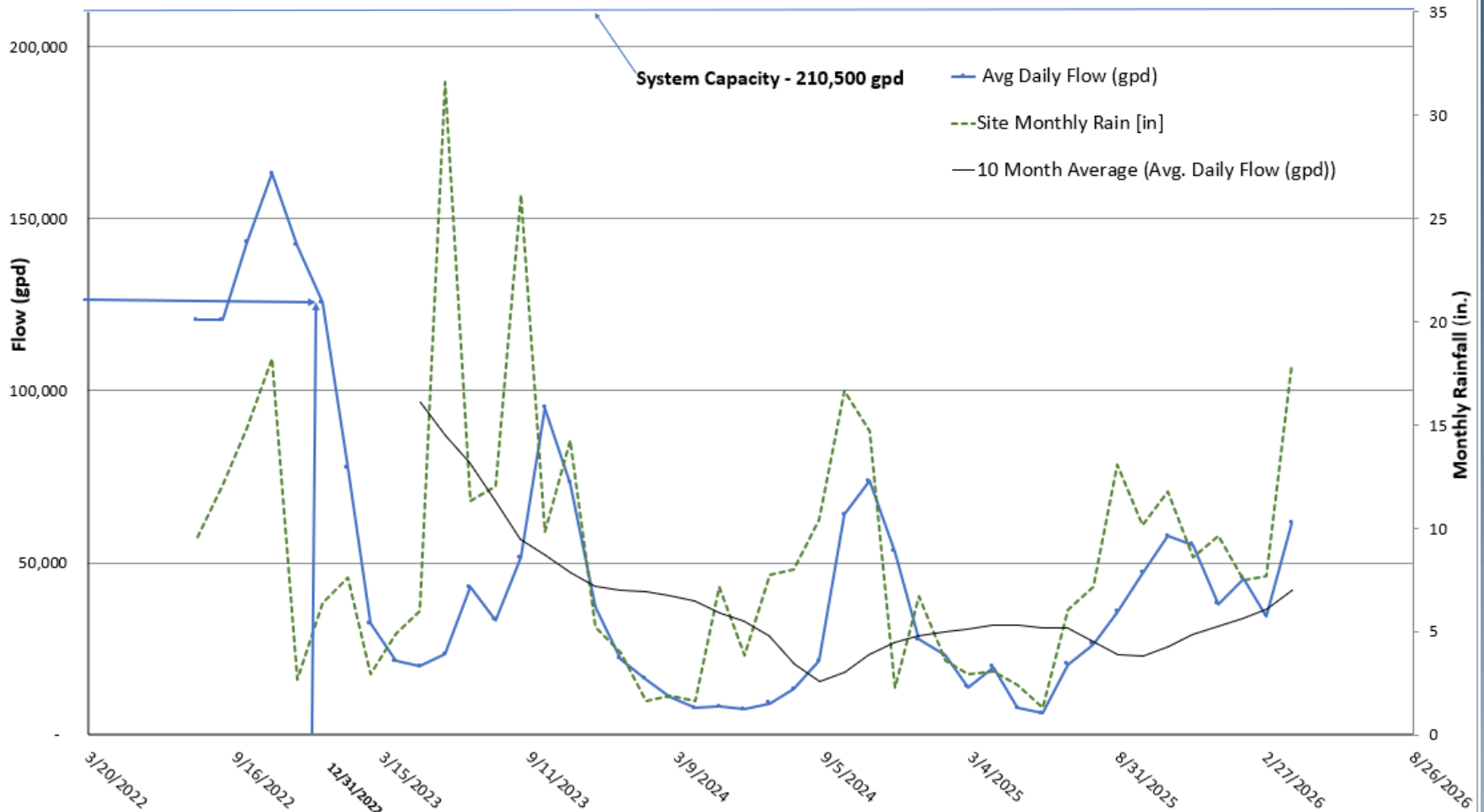

MISSION AND OBJECTIVES

- **Mission:** The Guam Solid Waste Authority (GSWA) is to provide a safe and healthy environment for the people of Guam through proper, timely, and efficient collection of refuse materials through the villages and urban areas to ensure their proper disposal in legally permitted facilities.
- **Goals and Objectives:** Under 28 GAR, Chapter 5, GSWA is to protect public health, safety and welfare by reducing or eliminating health hazards, fire hazards, offensive odors, and unsightly litter attributable to the accumulation of solid waste; to ensure proper, cost-effective and environmentally sound disposal of solid waste; to reduce the demand for landfill sites and conserve land resources by providing maximum recovery of usable materials of solid wastes within limits of economic feasibility; and to communicate with customers through educational efforts to increase recycling participation in the current recycling program to minimize waste and extend the life of the landfill.

FY2027 REVENUE ASSUMPTIONS

- Commercial and Government: 18-month historical data using tonnage collected at FY2027 rates (\$193/ton) with .35% projected growth rate. Discounted rates were used for large commercial haulers (\$183/ton).
- Residential: 18-month historical data using customer count increased by .45% projected growth at FY2027 rates (\$38/customer) less 3% allowance.
- Special Waste: 18-month historical data using tonnage collected at FY2027 rates (\$193/ton) with .35% projected growth rate.
- Transfer stations: 6-month historical data using actual revenues at .45% projected growth rate.
- Other income: 18-month historical data based on actual revenues at .45% projected growth rate..
- Interest: 6-month historical data using actual income earned.

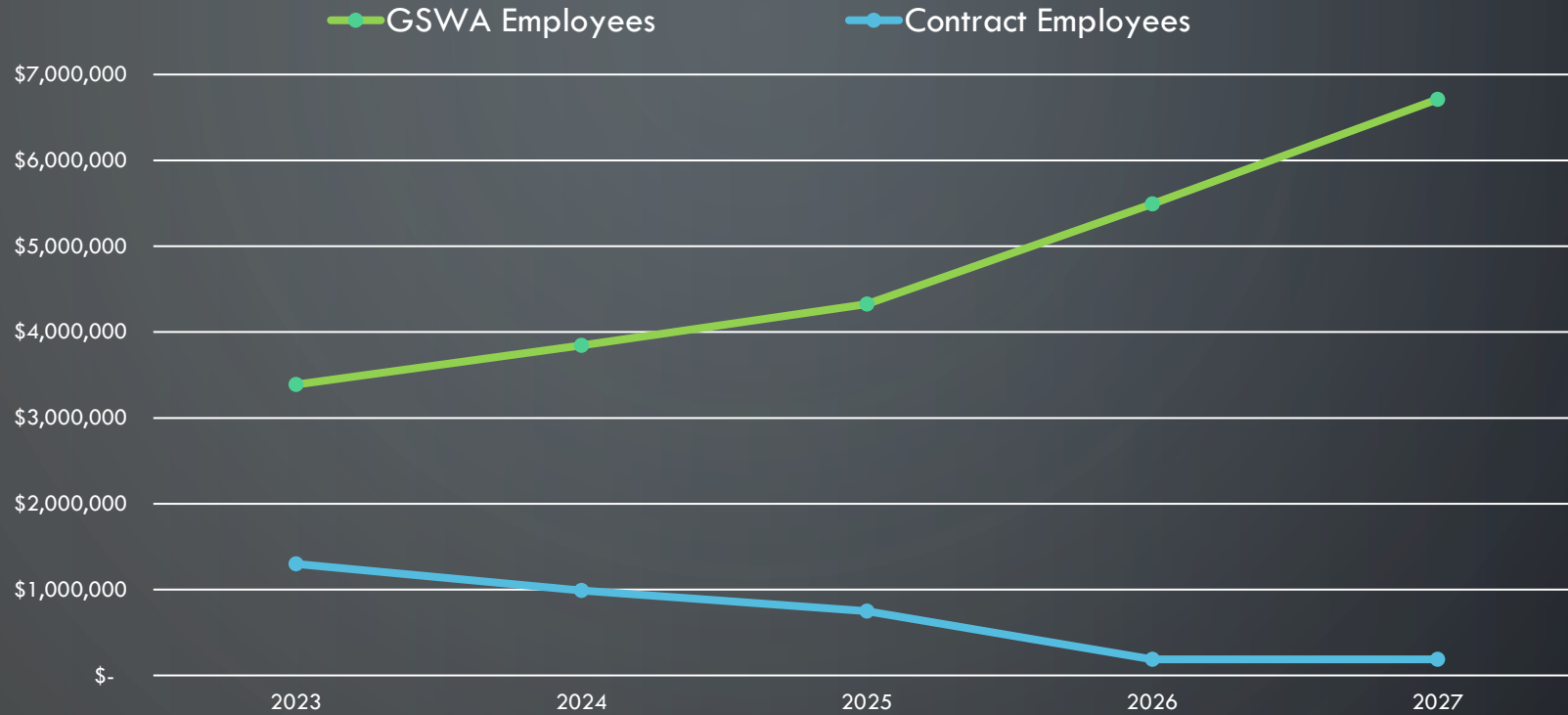

NOTABLE ACCOMPLISHMENTS FY2025-FY2026

- Take over of the Layon Landfill, with a capital asset purchase of \$1.3M.
- Transfer of temporary employees to permanent positions.
- Receipt of 3 Dodge Ram Trucks, 6 roll off containers, 3 compactors, 1 Car Crusher, 1 flatbed trucks, 2 rear loaders, 3 side loaders, 1 wheel loader, 1 utility service truck, 2 hopper trucks and the elevator installation to the administration building.
- Increase of rates approved by PUC over the next two fiscal years for the preparation of Layon cell closures and building of new cells.
- Implementation of the 5-day trash and recycle collections.
- Biodiesel project completed in April 2026 (cooking oil conversion), to save \$200K annually and renew GHG emissions.

FY2027 OUTLOOK

- Layon Infrastructure plan will redesign the remaining airspace and provide designs that are smaller, more economical to construct and operate. Also provide information for a long term capital improvement plan.
- Island-wide collection will spread utility costs more equitably amongst users.
- Converting used cooking oil to Biodiesel will reduce both fuel costs and carbon emissions.
- 5-day collection will improve operational efficiency and customer service with Alpine routing.
- Renegotiation of the Hauler Transfer Contract will also bring cost savings.

GSWA Board Resolution No. 2026-004 RELATIVE TO THE APPROVAL OF A BUDGET FOR THE GUAM SOLID WASTE AUTHORITY FOR FISCAL YEAR 2027

WHEREAS, the Guam Solid Waste Authority is an autonomous, public corporation of the Government of Guam; and

WHEREAS, Title 10 Chapter 51A §51A115 indicates that the Board shall authorize, by means of the annual budget, payment of demands against the Authority resulting from the exercise of its powers under the Guam Solid Waste Authority Act if the purposes and amounts of such demands are projected in which has been adopted by the Board after receiving recommendations from the General Manager; and

WHEREAS, the Annual Budget for the Guam Solid Waste Authority be funded by the anticipated revenues to be received and expended for the same fiscal year must be submitted by the Authority to *I Liheslaturan Guahan* and approved by law for the next fiscal year; and

WHEREAS, the Public Utilities Commission approved a rate adjustment for the Guam Solid Waste Authority to take effect on October 1, 2026, resulting in estimated additional tipping fee revenue of approximately \$1.2 million to fund Layon Reserves; and

WHEREAS, the Guam Solid Waste Authority has projected revenue of \$26,404,390 to fund Solid Waste Operations and FY2026 Ordot Post Closure fund balance of \$2,000,000 to pay for Ordot Post Closure Expenditures; and

WHEREAS, the Guam Solid Waste Authority has a total of three (3) funding sources, namely the Guam Solid Waste Operations, Recycling Fund and Fund Balance; and

WHEREAS, the Guam Solid Waste Authority General Manager has presented the proposed Annual Budget for Fiscal Year 2027 totaling \$28,404,390; and

WHEREAS, the Guam Solid Waste Authority General Manager has reviewed the budget to ensure that all budget expenditures are consistent with the strategic goals of the Authority; and

THEREFORE, BE IT RESOLVED by the Board of Directors as the Governing Body of the Guam Solid Waste Authority hereby approve the Fiscal Year 2027 proposed budget of \$28,404,390 (Exhibit A).

BE IT FURTHER RESOLVED that the Board of Guam Solid Waste Authority does hereby authorize the management team to submit the Fiscal Year 2027 Annual Budget to *I Liheslaturan Guahan*.




