Executive Director’s Report	Operational Updates Operational updates included continued coordination with the Office of Public Accountability (OPA) on the Government of Guam ethics training compliance audit, with all requested documents submitted on April 23, 2026. The Ethics in Government Program provided training to over 1,000 government employees in FY2026, averaging 145 participants monthly, while also receiving requests for specialized ethics trainings. The office is currently reviewing seven complaints, responding to two advisory opinion requests, and conducting consultations with government employees and community members to provide guidance on ethics-related matters. 	<p>Commission Update The Commission officially welcomed Atty. Genevieve Rapadas, who was confirmed by the 38th Guam Legislature on March 27, 2026, to serve on the Guam Ethics Commission. The Commission currently has five of seven commissioner seats filled, with two commissioners expected to term out this year and additional appointments under consideration.</p>	N/A	N/A	N/A
	<p>Legislative and Policy Developments An update was provided on Bill 214-38, which was passed by the Legislature on March 27, 2026, and became Public Law 38-122 on April 9, 2026, without the Governor’s signature. The Governor issued a letter expressing concerns regarding administrative penalties, vague language, and due process protections. The new law revises several provisions of the Guam Ethics Commission, including appointment procedures, quorum requirements, commissioner removal authority, public access to hearings and records, and the establishment of administrative penalties of up to \$5,000 per violation following a hearing conducted in accordance with applicable law.</p>	N/A	N/A	N/A
	<p>GECOM – Trust Meter An update was provided on the GECOM Trust Meter project, including completion of the April 16, 2026 kickoff meeting with New Data Solutions to discuss project milestones and responsibilities. Survey design and questionnaire development are underway, with a draft framework expected for review during the week of May 4–8, 2026. Fieldwork is targeted for June 2026, including CATI operations through call centers in Fiji and Australia, development of a public landing page, and preliminary cognitive testing scheduled for May 22, 2026. 	Legislative and Policy Development Bill 214-38 the Legislature continues to deliberate on the Bill in the March Session which began on Monday, March 23, 2026 and may run until the end of the week. <ul style="list-style-type: none"> Senators continued deliberations on the board's composition without reaching consensus. The bill, which failed yesterday, March 24, 2026, was reconsidered and passed today, returning to the third reading file for a possible final vote later this week. Key changes include standardizing the quorum to four members for all actions and removing commissioner stipends (previously \$50). Operational Updates

- On April 3, 2026 the Office of Public Accountability contacted our office to initiate an audit of Government of Guam employee's ethics training compliance. After review of the documents and information request our team met with the Public Auditor on April 10, 2026 to discuss current operations and potential issues regarding this audit topic. On April 23, 2026 our team have submitted all requested information and will continue to work with the OPA should they need anything further from the Commission on this.

- Ethics In Government Program Training:

- Complaints and Investigations: (7 complaints filed)

We continue to prepare all case files and will present to the Commission as we work on filling the vacant seats as well as on our new legislation enhancements to ensure we provide a clear pathway for cases going forward. We will be informing all complainants about our process as well as the 3-year statute of limitations that our current law allows for.

- Advisory Opinions: (2 Request for Advisory Opinions)

The Commission continues to field calls and inquiries regarding potential complaints and violations of the Ethics Code and have advise members of the community on the proper agencies to engage based on their circumstances and events as well as next steps with the Commission. I have asked our team to ensure we assist members of the community to the fullest extent possible and avoid simple referrals.

- Consultations:(6 in person/phone consultations)

We have seen an increase in request for consultations from various employees in the government regarding specific issues they have encountered. This is proving to be a beneficial step in enhancing awareness as well as providing more technical assistance for government officials and the general public

Commission Update

- I would like to officially welcome Atty. Genevieve Rapadas to the Guam Ethics Commission. On March 27,2026 the 38th Guam Legislature voted to confirm Ms. Genevieve P. Rapadas to the board of the Guam Ethics Commission. In addition, The Office of the Governor has notified us that her Swearing in Ceremony will be held on May 8,2026 at 2pm in the Large Conference Room in Adelup.
- Our Commission now has a total of 5 of 7 Commissioners, however 2 commissioners will be termed out this year, so additional Commissioners are being considered.

Legislative and Policy Developments

- UPDATE: Bill 214-38 – On March 27, 2026 the Legislature voted to pass Bill 214-38 and sent to the Governor’s Office for signature into law.
- On April 9,2026 the bill lapsed into now Public Law No. 38-122, without the governor’s signature. Her office instead shared an official letter regarding this law citing her reservations around the need for administrative penalties as well as vague language around the imposing of such fees and due process rights. A copy of her letter can be found on the Guam Legislature’s website.

GECOM - Trust Meter

- Project Planning – Kick off Meeting was held on April 16, 2026 with New Data Solutions and GECOM staff to discuss key milestones, deadlines, work responsibilities and expectations.
- Survey Instrument Design – Survey design and questionnaire being drafted by NDS with a draft framework expected to be delivered to GECOM for approval this week (May 4-8 2026).
- Fieldwork Planning – Overall fieldwork targeted for June 2026. NDS confirmed two call centers (Fiji and Australia) for the CATI approach. In addition, work on a landing page to incorporate FAQs and registration data for the Trust meter has commenced. A preliminary survey cognitive testing of participants will take place on May 22,2026 prior to general public release, to evaluate respondents’ comprehension to survey questions and identify any phrasing or ambiguous questions and statements. This will assist in improving survey design and ensure quality responses.
- Commissioners Feedback- New Data Solutions, would like to conduct an initial survey with our commissioners to obtain information on proper framing of the trust meter as well as anticipated outcomes.

Bill No. 214-38 (COR) would amend 4 GCA § 15403(c) in a manner that would require the Guam Ethics Commission (GECOM) to issue an administrative fine of up to \$5,000 per non-criminal violation of the code of ethics. The Legislature says these changes are needed to enforce ethics in the Government even though the Executive Director for the Ethics Commission testified on February 12, 2026, that there were only three cases referred to them in 2025. Disregarding the fact that there does not appear to be a need for this change, there are still fundamental issues with its language.

First, the Legislature claims to be strengthening the independence of GECOM by imposing a requirement on them to issue a fine in all cases that the Commission finds a violation occurred. GECOM will have no discretion as to whether or not to assess a fee when resolving the violation. Dictating to the Commission how they will resolve ethical violations does not increase their independence, it weakens it.

Second, the fines the Legislature is mandating GECOM to impose lack procedural due process rights. Nowhere in this bill did the Legislature provide an employee with an avenue to contest or appeal the required fine. The omission of an administrative or judicial remedy is significant. In Guam, we believe in the rule of law, and that principle requires that individuals affected by government action have a meaningful opportunity to be heard before penalties are imposed.

Third, the bill does not define what this "code of ethics" referred to in section 15403(c)(2) even is and Chapter 15 is silent in the definition section. Presumably, the Legislature is referring to Chapter 15 as a whole given the language found in 4 GCA § 15401(b). The law should make it clear to employees what conduct would result in a mandatory fine.

Finally, the violation language itself is vague. The Legislature mandates GECOM to impose this fine for *each* violation. How is the Legislature calculating a violation? Is it a single act? Each day the conduct occurred? Does the intent of the employee matter? For example, if an employee reasonably believed they were being ethical but the Commission later determined they were not, then this employee would be subjected to at least one mandatory fee for their violation, if not more, depending on how the violation is calculated. Furthermore, as stated above, said employee would have no remedy on challenging such a finding by the Commission. No employee of the Government, serving the people of Guam, should be subjected to a vague statute in which it is unclear what conduct is prohibited and when there are no procedural due process rights as I discussed above.

Despite my foregoing reservations, I am allowing Bill No. 214-38 (COR) to lapse into law without my signature as **Public Law No. 38-122**. It aligns GECOM's quorum and decision-making standards with that of the Civil Service Commission (CSC). Under current law, GECOM requires five of its seven members in order to take action. The CSC, like GECOM, has seven members of which only four are required for quorum and to cast an affirmative vote when taking action. This bill would bring parity to GECOM in its ability to oversee ethics complaints by changing its requirement from five members to four.

As part of implementing the new administrative fines, the bill requires GECOM to develop and enact regulations under the Administrative Adjudication Law. I ask the Commission to consider fairness and due process when drafting the regulations.
