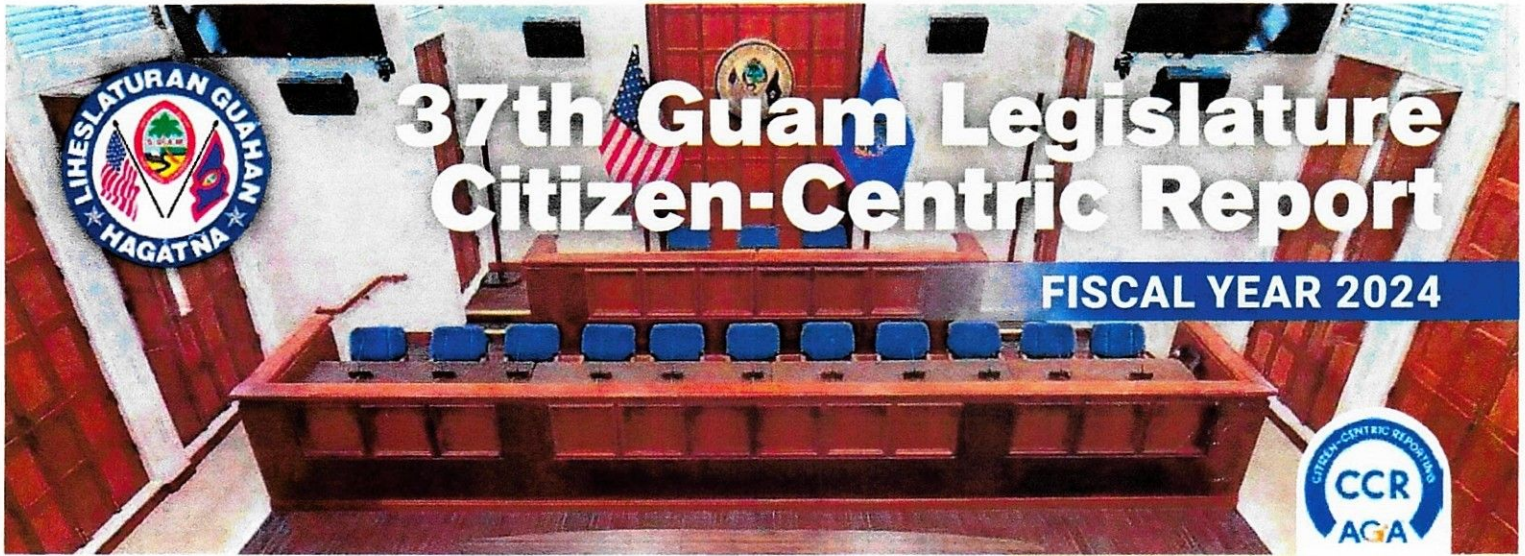

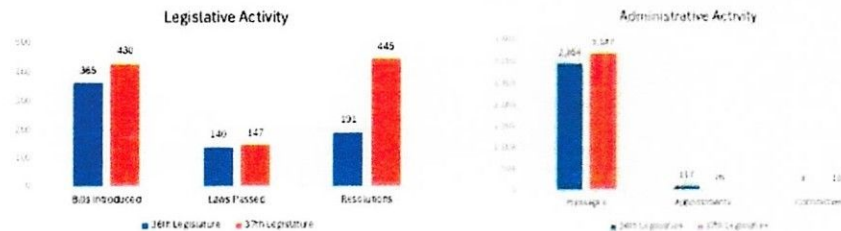

This next section are highlights from the Transition Report from the Chairman on Rules, Senator Chris Barnett of the 37th Guam Legislature:

While some initiatives came with their challenges, the Legislature faced them head-on with remarkable resilience, especially in the wake of the devastating Typhoon Mawar. Amid this crisis, we successfully navigated several obstacles, including extensive damage to two critical properties: **the leased U.S. Post Office building and the Garden House which had previously been used for storing legislative files.**

LEGISLATIVE RECORDS

Clerk of the Legislature

In March 2023, Joaquin “Quin” P. Taitague assumed the position of Clerk of the Legislature and has effectively carried out his duties throughout the 37th Guam Legislature, despite facing challenges that have impacted the completion and management of legislative session journals and archival files.

Legislative Session Journals

The process of completing the Legislative Session Journals requires a thorough re-evaluation. The Clerk’s Office is responsible for a wide range of duties, including processing Bills, Resolutions, and Certificates, as well as managing Messages and Communications, Appointment Reports, Referrals, Executive Orders, and other administrative duties.

Archival Files

In May 2023, Typhoon Mawar caused significant damage to the Garden House, resulting in flooding and, over time, created a health hazard due to poor ventilation of the documents stored there. Concerns included damaged boxes, possible termite infestation, and mold. All records stored there have been digitized since 2020.

Legal Considerations

All records created or received by public officials are regarded as government property. Under 5 GCA § 2607, these records cannot be destroyed or disposed of unless authorized by law. Disposal requires determination that records no longer hold value and must follow legal processes.

FACILITIES & MAINTENANCE

This section provides an overview of legislative buildings including Plaza de España, Azotea, Garden House, U.S. Post Office Building, and a few of the more significant projects affecting the Guam Congress Building.

- Garden House sustained roof damage and leaks, also has mold and ventilation issues, and Air Conditioning system failure.

Completed Repairs (U.S. Post Office Building):

- Roof replacement and coating, gutter replacement, and interior wall repainting.

Solar Panel Initiatives

- Repairs to the solar panels were completed as part of an ongoing effort to enhance energy efficiency and sustainability. Repairs were completed September 2024.

Air Cooled Chiller System

- The temporary chiller system in use is leased month-to-month from Tony’s Workshop. A new 90-ton chiller system from JWS is expected by April 2025.

INFORMATION TECHNOLOGY & MODERNIZATION

The Audio-Visual (AV) and Management Information Systems (MIS) divisions have made significant progress in infrastructure modernization.

- 80% of legacy systems upgraded- 20% still requires investment in the next term.
