Invoices from above vendors were unfortunately either overlooked or were not sent/received in time so that payments can be made prior to FY25 closeout deadline.

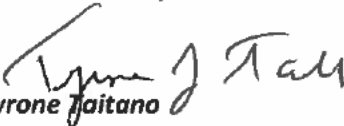
In the effort to clear our outstanding obligations, the above amounts are requested to pay off all outstanding invoices to GTA Teleguam.
