

The St. John's Knights had the most players on the First Team with five, while Guam High, Harvest and Southern

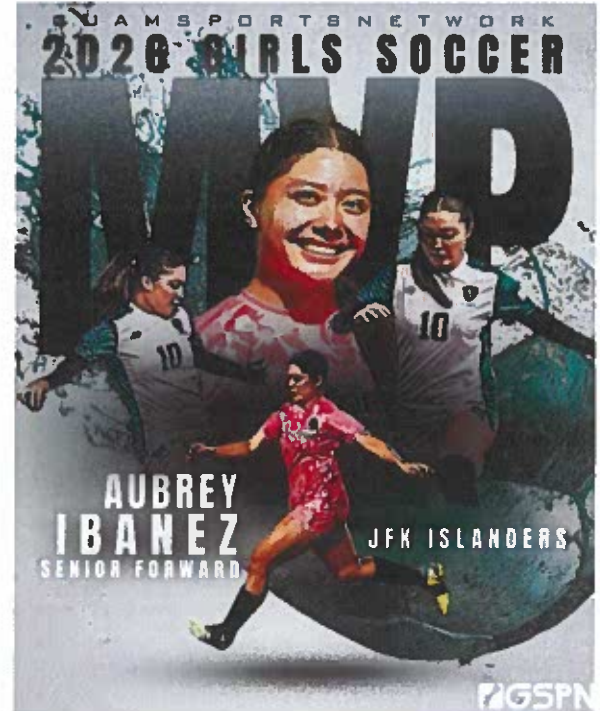
had one selection apiece.
