Guam's strong performance at last year's Oceania U18 Championships, where the team recorded a notable victory over Australia, the AVC Beach Tour presents the next step in her development by placing Guam's athletes on a broader continental stage.

"After the success we had in beach volleyball last year, it's very exciting to

participate in another tournament," said Chen. "We've worked hard for opportunities like this, and I hope we continue to grow and improve from the experience."

The event also carries special personal meaning for Chen, who was born in Taiwan and will now return to compete there while representing Guam.

"It's pretty cool to be competing in my birthplace," Chen said. "I have a lot of family there, and I'm sure

it'll be fun. But ultimately, I'm proud to be representing Guam, my home."

For Eugenia, the Pingtung Open will mark her first appearance as a Guam national team player, making the tournament a significant personal milestone and an important step in her development as an international beach volleyball athlete. Earlier this year, Eugenia represented Guam at the BVR Nuvali Open in the Philippines, where she and partner

Landen DeVera advanced to the championship match of the U18 division. The AVC Beach Tour now provides her first opportunity to compete at the senior international level.

"This tournament is an important opportunity for our athletes to gain higher-level international experience, represent Guam with pride, and continue building the foundation for our beach volleyball program," said Coach Manny Guarin. "For Niesha and Carmen, this is more than just a tournament. They will be challenged by experienced women's players, but that is exactly the kind of opportunity that helps young athletes grow."

Guam has selected traveling teams across three divisions: Senior, Under-20, and Under-18, reflecting the continued growth and development of the island's national beach volleyball program.

		The Board discussed legal guidance received from the Attorney General’s Office regarding the eligibility of applicants who obtained training hours from an establishment operating with expired licenses and permits. It was explained that clarification had been sought to avoid any misunderstanding concerning the interpretation of Guam law and Board regulations. The guidance referenced provisions of the Guam Code Annotated stating that applicants who completed a cosmetology program from a school approved by the Board may be administered examinations, noting that the statutes governing examinations do not specifically identify licensure as a condition of Board approval. However, members also reviewed separate statutory provisions concerning apprenticeships, which explicitly require that training be conducted in a licensed cosmetological establishment under the supervision of a Board-approved licensee. Board members expressed concern regarding the apparent inconsistency between the examination and apprenticeship provisions of the law. It was noted that while the establishment may have been approved at the time of enrollment, the establishment license, business license, and sanitary permit had all expired during the period in question, indicating that the establishment should not have been operating legally at that time. Board members stated that the hours obtained during the period of expired licensure could therefore be considered invalid under the apprenticeship requirements. Additional concerns were raised regarding the establishment’s compliance with licensing laws, including failure to properly display licenses and adhere to statutory and regulatory requirements. R. Santos acknowledged the Attorney General’s guidance that the statutes governing examinations do not expressly require licensure as a condition of approval, stated he remained uncomfortable approving the applicant’s hours due to concerns about legal exposure, regulatory consistency, and the precedent such a decision could create for similarly situated applicants. Throughout the discussion, Board members emphasized that their concerns were not directed toward punishing the applicant personally, but rather ensuring compliance with applicable laws and regulations governing professional licensure and public protection. Members stated that additional research and legal review were necessary before making a final determination, particularly because any decision made could establish precedent for future cases involving the same school. Due to the unresolved concerns and lack of

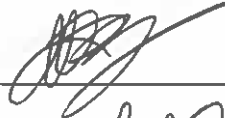

		island instructor and educational institution concerning the use of online instruction to satisfy contact hour requirements. Members noted that the issue involved whether online theory coursework could serve as a valid method for students to obtain required training hours while improving accessibility for working students and individuals enrolled in programs not readily available on Guam, such as instructor training courses. Board members acknowledged that previous applicants seeking approval for online coursework had been denied, and concerns were raised about establishing a new precedent by approving online instruction. Distinctions were discussed between accredited educational institutions, such as community colleges, and independent schools or instructors that may not follow the same curriculum standards. Members also noted that instructor training programs differ from cosmetology student programs because some instructor coursework may already be accepted through accredited college education courses. The Board further discussed the contact hour requirements established under Guam law, emphasizing that cosmetology licensure is based on documented training hours rather than solely academic performance. Concerns were expressed regarding the Board's ability to verify attendance, participation, and the authenticity of student engagement in an online learning environment, including the possibility of misuse of online login systems. R. Santos suggested the possibility of approving a limited number of online theory hours rather than allowing all coursework to be completed remotely. However, all members agreed that additional discussion and review would be necessary before any decision could be made.
