Executive Director's Report	Operational Update The Guam Summer Youth Employment Program (GSYEP) welcomed two interns from June 15 – July 25, 2026: Ms. Amari Asuncion (Tiyon High School) and Mr. Sebastian Dizon (Notre Dame High School), who will gain experience in administration, marketing, branding, and event coordination. 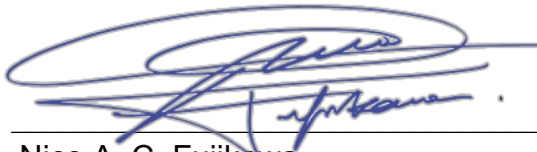

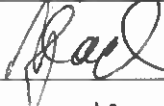
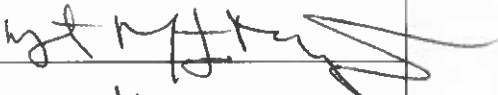

The new law revises several provisions of the Guam Ethics Commission, including appointment procedures, quorum requirements, commissioner removal authority, public access to hearings and records, and the establishment of administrative penalties of up to \$5,000 per violation following a hearing conducted in accordance with applicable law. - Complaints and Investigations: (14 complaints filed)

We continue to prepare all case files and will present to the Commission in the July 2026 Regular Meeting. We continue to inform the community and all complainants about our processes to provide them a clear pathway forward.

- Advisory Opinions: (2 Request for Advisory Opinions)

The Commission continues to field calls and inquiries regarding ethical dilemmas or relevant matters of the Ethics Code and have advised the community on the proper agencies to engage based on their circumstances and events as well as next steps with the Commission.

- Consultations:(8 in person/phone consultations)

We have seen an increase in request for consultations from various employees in the government regarding specific issues they have encountered. I have asked our team to ensure we assist members of the community to the fullest extent possible and avoid simple referrals. This is proving to be a beneficial step in enhancing awareness as well as providing more technical assistance for government officials and the general public.

Commission Update

- Mr. Joshua Miller's packet was approved by the Governor's office and sent to the Legislature on May 26, 2026 for next steps in his confirmation process.
- Our Commission now has a total of 5 of 7 Commissioners, however 2 commissioners will be termed out this year, so additional Commissioners are being considered and I welcome any recommendations for potential nominees.

Legislative and Policy Developments

- In accordance with P.L. 38-122, We have drafted our policy on "Administrative Fines" for the Commissioners review and discussion. This policy creates a clear objective process on assessing respective fines per case per violation. The law allows the Commission to assess a fine of up to \$5,000.00 per Ethics Violation and our draft policy will guide Commissioners on a fine commensurate with the violations.

GECOM – Public Trust Index Update:

- **Survey Instrument** – A draft survey instrument was completed on May 22, 2026. We are currently conducting cognitive testing on the survey to analyze participants comprehension, pacing, and engagement of the survey.
- An official registration page for interested participants has been set up and will be announced to the public in the coming weeks. This will allow us to drive demand for the participation as well enable participants to determine how they would like to engage in the survey. (Online vs Telephone interview)
- Final Survey design completion is targeted by June 26, 2026 with a marketing campaign being scheduled for June 29, 2026 through July 8, 2026.
- Official Public Trust Index Launch is scheduled for Wednesday July 8, 2026 (GECOM's 30th Anniversary)
