THE AGENCY

WE ARE GUAM EPA

HISTORY | Acting Gov. Kurt S. Moylan Signed Public Law 11-191 on December 7, 1972 that enabled the creation of the Guam Environmental Protection Agency. The Public Law gave responsibilities once given to different agencies and commissions to the newly formed Guam EPA. On March 3, the following year, Guam EPA officially started work and took up residence at the Harmon Plaza. Today, the agency is housed in two buildings in Tiyan Barrigada, Guam.

MISSION STATEMENT | The Agency's public policy of this territory of Guam is that a high quality environment be maintained at all times to guarantee an enjoyable life for all people at present and in the future, and that environmental degradation of the quality of land, water and air by any pollutants, including all physical, chemical and biological agents, should not be allowed. To these ends, it is the purpose of this Act to provide a united, integrated, and comprehensive territory-wide program of environmental protection and to provide a framework to fulfill that task.

ABOUT THE AGENCY | The Guam Environmental Protection Agency is a semiautonomous agency of the Government of Guam. Through an integrated framework, regulations, and core divisions, Guam EPA focuses on protecting the health of the community and intends on maintaining a sustainable and beautiful environment for the people of Guam. Guam EPA provides continued implementation throughout the Island of Guam, inclusive of air, land and water. GEPA also provides enforcement, permitting and public service through the various programs such as Water, Solid Waste, Hazardous Waste and Air Pollution. Protection of the island's air, land and water are paramount to the agency.

The Agency's policy is established by a Board of Directors. The Board meets once a month, and meetings are open to the public. Board Members are appointed by the Governor to three-year terms. Under Guam law, the Guam EPA Board of Directors also serves as an appellate body. Any citizen who believes he or she has been aggrieved by an action or decision of the Guam EPA Administrator can request a hearing before the Board. The Administrator and Deputy Administrator of Guam EPA are appointed by the Board of Directors.

AGENCY HIGHLIGHTS

ENVIRONMENTAL MONITORING AND WATER QUALITY

"Composting in Every Village" Grant

Supported by a federal Solid Waste Infrastructure for Recycling (SWIFR) grant, Guam EPA partnered with local organization Guahan Sustainable Culture to launch village-level training sessions, teaching residents how to grow local produce, create compost, amend soil, and reduce residential food waste to divert food and yard waste from landfills. A massive 146,798 tons of green waste and food scraps was composted.

Dededo Transfer Station Cleanup & New HQ

The federal EPA initiated the removal of over 44,000 cubic yards of contaminated soil and debris. The site will now be redeveloped to house the new Guam EPA headquarters and an environmental laboratory.

Water Resource Protection

The agency monitored recreational waters territory-wide, completing routine weekly public advisories for beaches.

Streamlined Military Permitting Pilot

To combat permit processing delays, the agency launched a pilot program. This allows third-party professional engineers to use Guam EPA checklists for preliminary design reviews, speeding up military-related infrastructure projects while staff retain final approval.

Water Resource Protection

Guam EPA assisted the Port Authority of Guam launch a \$2.4 million EPA-backed program to establish mobile emissions inventories, update net-zero strategies, and plan for the electrification of port operations.222

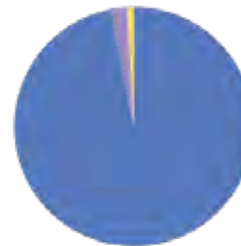

FEDERAL EXPENDITURES

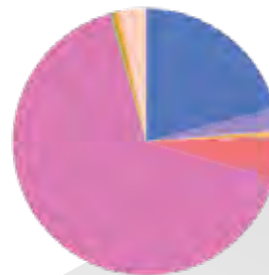
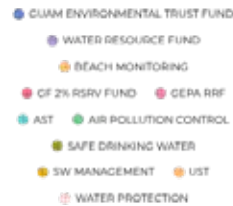

As we embark on the upcoming Fiscal year, our agency looks to the following:

- Implement the Interim Action Level (IAL) for Dieldrin and continue public engagement on longterm standards.
- Begin implementation of the Tumon Bay Chlordane & Dieldrin TMDL, including monitoring, watershed actions, and restoration planning.
- Advance formal rulemaking to update Onsite Wastewater Treatment & Disposal System (OWTDS) regulations following FY24 interim requirements for Type 2 and Type4 toilet facilities.
- Modernize environmental statutes and permitting frameworks to improve clarity and efficiency.
- Improve digital permitting, data management, and public access to environmental information.
- Advance Clean Air Act SIP compliance for the PitiCabras SO₂ nonattainment area by completing the 2020 SO₂ Emissions Inventory submission and carrying out the scheduled April-May 2025 public comment and hearing process.
