Pursuant to Public Law 38-60, the Fiscal Year 2026 Budget Act, requiring all districts to report encumbrances and expenditures on a quarterly basis, the Office of the People of Yona respectfully submits its Fiscal Year 2026 Third Quarter Report.

MCOG OPS General Fund – Supplies for officials and equipment were purchased, as well as supplies for daily operations to maintain the upkeep of the village of Yona. Roads and areas maintained during January, February, and March include: Salas Road, Joaquin Aguon Road, Chalan Aguon, As Fejeran, As Suilo Road, As Kukiri, Dolilie Road, Chalan Teleforo Road, Chalan Jota, Chalan Tailagan.

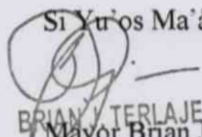
VOMBPS / Guam Educational Facilities Fund – Supplies were purchased for the upkeep and daily operations in the village of Yona. Roads maintained during October, November, and December include: Salas Road, Joaquin Aguon Road, Chalan Aguon, As Fejeran, As Suilo Road, As Kukiri, Dolilie Road, Chalan Teleforo Road, Chalan Jota, Chalan Tailagan, Flame Tree Drive, LeoPalace, Windward Hills, Baza Gardens.

VOMBPS / General Fund – Supplies for officials and equipment were purchased, as well as supplies for daily operations to maintain the upkeep of the village of Yona. Roads and areas maintained include: Baza Gardens, Windward Hills, Baseball Fields, Yona Mayor's Office, Gym, C. Center.

MCOG Miscellaneous Operations Supplemental – Equipment is in the process of being purchased, along with supplies for daily operations to maintain the upkeep of the village of Yona. Roads and areas to be maintained include: Baza Gardens, Windward Hills, Baseball Fields, Yona Mayor's Office, Gym, Community Center, Senior Community Center, Tagachang Beach, Sister Mary Eucharita st.
