There is nothing for office supplies, although \$7,000 had been appropriated, the Board is only allotted \$450, and have used \$6450, the available balance is \$876.44. The equipment budget remained largely untouched, with an appropriation and available balance of \$2,041.84, the Board is only allotted a dollar, because in essence the Board's equipment needs were being met through HPLO resources, so the Board still has a balance of \$2,041.08. The miscellaneous and payments category had a total appropriation and allotment of \$19,000, of which \$8,000 had been used during May, leaving an available balance of \$11,000 as of May 31, 2026. Board members requested clarification regarding the miscellaneous payments category. It was explained that expenditures within this category primarily included board member stipends and annual dues to the Federation of Regulatory Boards, which supports multiple professional regulatory boards, including psychology and counseling boards. Additional discussion focused on the reported \$8,000 expenditure and the remaining balance of \$11,000, which was confirmed as the available balance as of May 31, 2026. It was further noted that budget appropriations, allotments, expenditures, and available balances may fluctuate from month to month, as funds can be reprogrammed by authorized entities, including the DOA and the Director of Public Health.

		i. Bill No. 295-38: “Relative to school psychology licensure; and to amend §12101(b) and §12802(a) of chapter 12, title 10, Guam Code Annotated, relative to including school psychology in the healing arts and allied health professions definitions”. Dr. Balajadia informed the Board that legislation establishing the school psychologist designation had been passed and signed into law. Discussion focused on implementing the new licensure category under the existing psychology profession and developing the necessary application forms and procedures. It was noted that six DOE school psychologists would be grandfathered under the law but would still be required to submit applications and supporting documentation to establish licensure files. The Board emphasized that the law provides a 90-day period for eligible individuals to complete the application process and encouraged prompt submission of all required materials. The Board further clarified that the school psychologist designation is not a separate profession but a specialty within the psychology discipline. The new licensure category was created to formally recognize qualified school psychologists and align Guam with national standards. Future applicants seeking licensure as school psychologists will be required to complete the standard initial application process, pay applicable fees, and satisfy all licensing requirements. Individuals who currently hold other professional licenses, such as Licensed Professional Counselor or Marriage and Family Therapist licenses, may maintain those credentials separately while obtaining school psychologist licensure. Additional discussion addressed staffing implications for schools and confirmed that individuals hired under the new law would be required to obtain licensure as school psychologists. The Board noted that the school psychologist category will be incorporated into existing psychology regulations as authorized by law. The Board also discussed developing a certification process in coordination with the DOE. Clarification was provided that licensure is the primary credential required to practice, while certification serves as an additional professional qualification and does not	GBAHE		Noted

	ii. Bill No. 308-38: “Relative to regulating the training of clinical psychologists to allow for supervision in Guam”. The Board discussed proposed legislation relating to the supervision and training requirements of clinical psychologists. It was noted that while current law addresses supervision, the proposed bill would provide greater clarity regarding the qualifications necessary to serve as a supervisor. Board members emphasized that professional licensure alone does not automatically qualify an individual to provide clinical supervision and that effective supervision requires additional training, experience, and competency in supervisory practices. Discussion also addressed national trends and industry standards, noting that many jurisdictions are moving toward requiring specialized education, continuing education units, and formal training in supervision, in addition to years of professional experience. Wishing you all the best in your next chapter," the Kings posted on X in announcing the move.

DeRozan has averaged 21.1 points, 4.3 rebounds, 4.1 assists and 1.0 blocked shots in 1,264 games with the Toronto Raptors, San Antonio Spurs, Chicago Bulls

and the Kings.

The 36-year-old American, who helped the United States to Olympic gold at Rio in 2016 and the 2014 Basketball World Cup crown, averaged 18.4 points, 4.1 assists, 2.9 rebounds and 1.0 blocked shots a game last season.

DeRozan's teams, however, missed the playoffs in six of past seven seasons, including of his campaigns with Sacramento.

DeRozan ranks fifth among active NBA players in scoring, 16th on the NBA's all-time scoring list with 26,711 points.

one except England and it is special because they are a major nation, a powerhouse, and it is always nice to play against a side like that, especially in a World Cup semifinal," said Messi after Argentina beat Switzerland in Kansas City in the last eight.

Emulating Maradona

The man who emulated Diego Maradona by inspiring Argentina to World Cup glory in Qatar four years ago will now hope to leave a similar mark on En-

gland as his legendary predecessor.

Any meeting of these countries evokes memories of the 1986 quarter-final at the Estadio Azteca in Mexico City, when Maradona punched in to score the 'Hand of God' opener and then ran past half the England defense for his team's second goal — perhaps the greatest World Cup goal of all time.

Messi has not scored one quite like that, but ahead of the semi-finals of the current tournament he had scored more World Cup goals than any other player.

With 21 goals from a tournament record 32 appearances, he led France

skipper Kylian Mbappe by one after the quarterfinals.

The Inter Miami player had found the net in nine consecutive World Cup matches before the Switzerland game, when he let others — notably Julian Alvarez — take over the goalscoring duties.

Argentina are now one game away from reaching another World Cup final, as they aim to become the first team to retain the trophy since Brazil in 1962.

It would be a third final in four World Cups, and Messi could follow in the footsteps of Brazil great Cafu. The full-back played in three in a row from 1994 to 2002 — even Maradona

only played in two.

"Getting to another semi-final is not a normal mundane thing, so there's something we should all enjoy because we know if it will happen again," Messi said.

The England players hope to enjoy it as well.

"It's a once-in-a-life opportunity," Nico O'Neil, who is likely to come against Messi if he stays left-back, told BBC Radio Live.

"He's coming toward the end of his career. For me personally, he's the player to ever touch a ball pitch. And yeah, I wait for the challenge."
