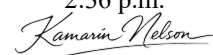

SOLE SOURCE

This purchase through this quote can be justified as a sole source procurement, because it is determined that GuamWEBZ is the only one source per GCA § 5214 (as included below) for the required supply and service, because only GuamWEBZ has authorized access to the proprietary source code which runs the existing currently utilized website for GSWA. GuamWEBZ owns the said source code. This sole source reference date is from October 01, 2025 – September 30, 2026.

*§ 5214. Sole Source Procurement. A contract may be awarded for a supply, service, or construction item without competition when, under regulations promulgated by the Policy Office, the Chief Procurement Officer, the Director of Public Works, the head of a purchasing agency, or a designee of either officer above the level of the Procurement Officer determines in writing that **there is only one source for the required supply, service or construction item.***

The interface is designed to cover the accessibility requirements relating to the UI, the design, and the readability of the GSWA website.

By using this interface, visually impaired users, users with cognitive disabilities, epileptic users, and others can modify the GSWA website design to meet their specific individual needs. Users can choose a pre-built disability profile, for example, the "Visually Impaired Profile", and immediately get a bulk of adjustments to help them browse more easily.

Alternatively, or in addition to the profiles, users choose to enable different adjustments, such as to increase font sizes, change color contrasts, stop animations, and more.

Daily Compliance:

The website would be scanned and made accessibly on a daily basis.

GSWA will receive an "Accessibility Statement and Certificate" right within the website interface.
