### **RELATIVE TO INCREASING THE BOARD STIPEND FOR COMMISSIONERS OF THE CIVIL SERVICE COMMISSION (CSC) CSC RESOLUTION NO. 2026-002**

WHEREAS, CSC recognized that prior to the year 2022, the Guam Parole Board had trouble making a quorum for many years. After the Guam Legislature enacted law to increase stipends from Fifty Dollars (\$50.00) to Two Hundred Fifty Dollars (\$250.00), the Guam Parole Board successfully held meetings to conduct business; and,

WHEREAS, the CSC is experiencing complications in enlisting citizens to fill the two (2) vacant Commissioner positions and the five (5) current Commissioners are tasked with unending work; and,

WHEREAS, the complexity of personnel appeals, grievances, and merit system oversight continues to grow, it is vital that we offer a stipend that respects their service and helps attract and retain highly qualified public servants to these critical roles; and,

WHEREAS, the current compensation rate for our Commissioners has remained stagnant for decades and no longer reflects the gravity, time commitment, or quasi-judicial responsibilities required of individuals serving on the Commission; and,

WHEREAS, the CSC believes that a Two Hundred Fifty Dollars (\$250.00) stipend per meeting would help retain the five (5) current Commissioners and fill the two (2) current vacancies; and,

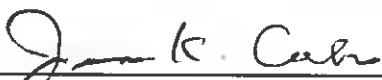
WHEREAS, the CSC is mandated to comply with time and case management standards for adverse action and grievance appeals, and the quicker resolution of appeals would save money to the government and that "Justice delayed is Justice denied"; and,

WHEREAS, a Two Hundred Fifty Dollars (\$250.00) board stipend promotes a healthy merit system; and;

BE IT RESOLVED, that the CSC requests the legislature to consider amending 4 GCA §4401(g) and 5 GCA §43104 (a) raising the CSC board stipend and funding of the CSC Commissioners to Two Hundred Fifty Dollars (\$250.00) per meeting; and,

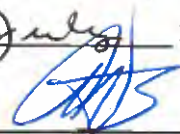
BE IT FURTHER RESOLVED that Daniel D. Leon Guerrero, CSC Executive Director, is authorized to work with the Guam Legislature on increasing the CSC Board Stipend. This resolution shall be transmitted to the 38<sup>th</sup> Guam Legislature ~ *I Mina'trentai Ocho Na Liheslaturan Guåhan.*

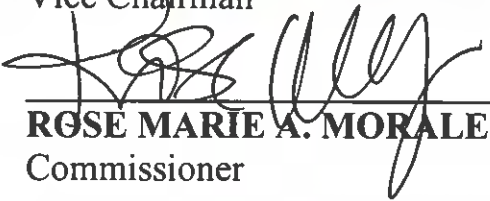
