The University of Guam (UOG) was established in 1952 as the Territorial College of Guam. It officially became the University of Guam in 1968 through Public Law 9-233. UOG became a land-grant university in 1972 and gained administrative autonomy as a nonprofit public corporation in 1976 through the enactment of "The Higher Education Act of 1976." In 2022, UOG achieved Sea Grant Institutional Program status, making it both a Land Grant and Sea Grant institution.

UOG is accredited by the WASC Senior College and University Commission (WSCUC) and offers baccalaureate, master's, and doctoral degree programs. Through its mission of instruction, research, and community outreach, UOG continues to impact the quality of life of Pacific Island societies, including students from various ethnicities, who will become the region's next generation of leaders.

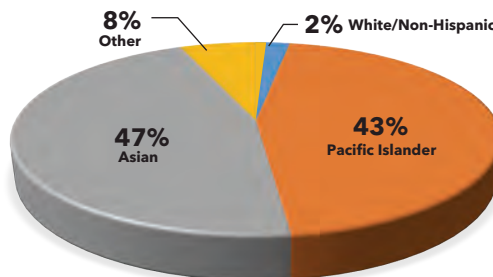

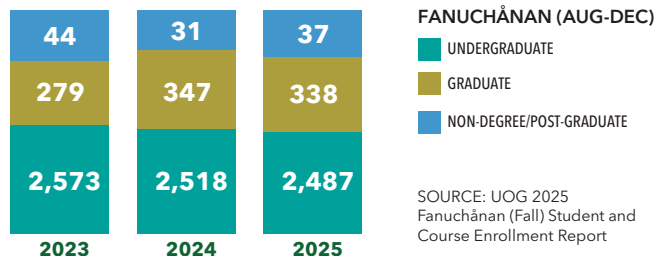

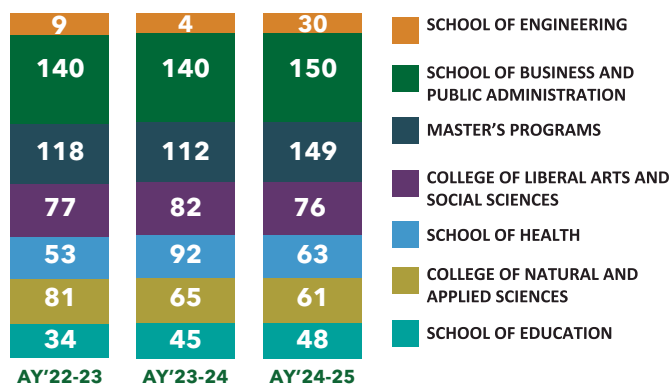
ENROLLMENT BY DEGREE LEVEL



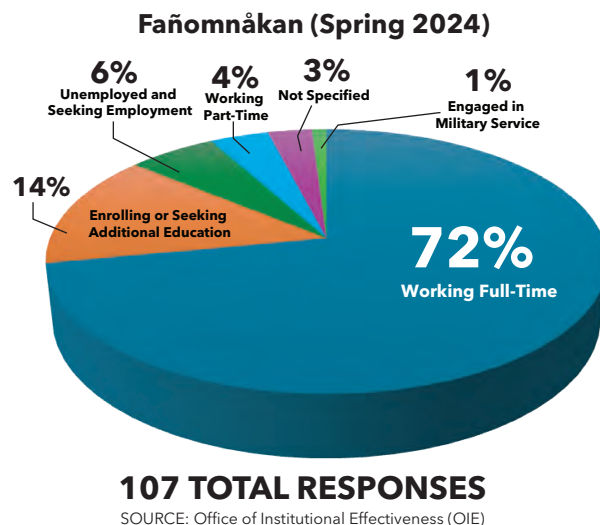
GRADUATES IN ACADEMIC YEAR 2024-2025

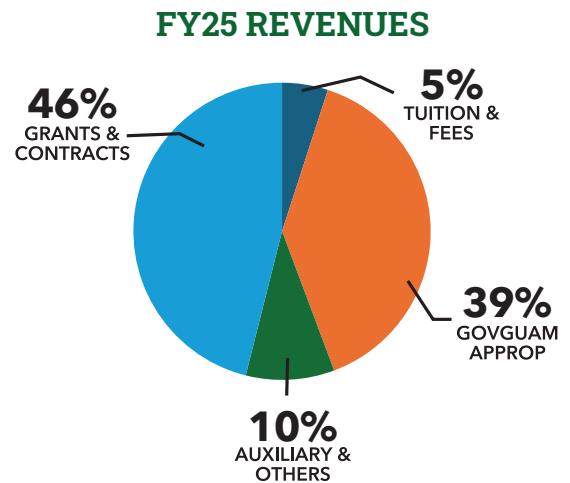
FINANCIAL PERFORMANCE

COMPARATIVE REVENUES (IN \$1,000)

In FY2025, university-generated revenues totaled \$80.1 million, or 58% of the University's total revenue of \$137.6 million, while the Government of Guam allotment contributed \$54.1 million, or 39%. Net tuition and fees totaled \$6.9 million, with the change reflecting University-funded financial aid and scholarships that help reduce students' out-of-pocket costs. The University received a one-time \$5.7 million supplemental appropriation under Guam Public Law 38-8 for repairs, maintenance, capital improvements, and accreditation priorities.

Grant activity remained strong, supported by the \$20 million National Science Foundation EPSCoR grant, the \$10 million U.S. Department of Agriculture NextGen grant, and new NSF EPSCoR CORE and E-RISE II awards received in 2025. Grant-funded activity also reflected continued investment in four major campus construction projects. Auxiliary and other revenues increased, primarily due to typhoon-related insurance proceeds.

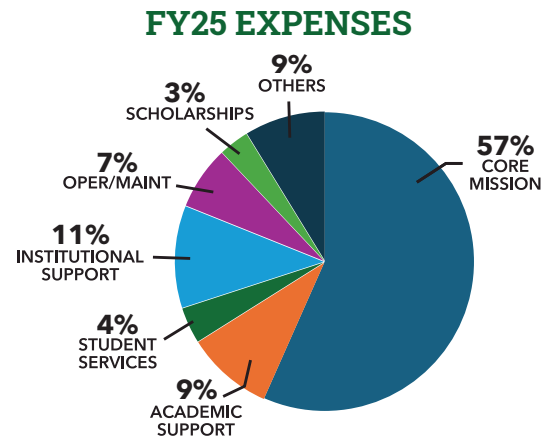


COMPARATIVE EXPENSES (IN \$1,000)

The decrease in expenses was primarily due to reductions in operational and maintenance costs, including utilities, repairs, and supplies, along with changes in several other areas. Of the \$125 million in total expenses in FY2025, \$70.8 million, or 57%, was directly allocated to the University's core mission of instruction, public service, and research.

In FY2025, the University transferred the Guam Cultural Repository (GCR) to the Department of Chamorro Affairs following the completion of its three-year operating period, which ended in September 2025. The University also recognized \$3.9 million in employee leave expenses under a new accounting standard, resulting in the restatement of FY2024 financials.

Artemio "Ricky" Hernandez, Ph.D., CGFM, CPPO, AIF was selected as the University of Guam's new Vice President, Administration and Finance and Chief Business Officer effective January 12, 2026. He continues to serve on the Research Corporation of UOG Board of Directors as Treasurer. As a UOG alumnus and Adjunct Faculty, Dr. Hernandez has described his appointment as an opportunity to give back to the institution that has given him so much.

OUR CHALLENGES

The University faces several challenges:

- **One Big Beautiful Bill Act:** The University of Guam's students may face impacts to their federal student aid due to the changes to the Act. Revisions to federal financial aid policies could have a greater effect on student enrollment, college affordability, and degree completion compared to other educational institutions.
- **Financial Pressures:** The University relies heavily on federal grant, local, and tuition revenues to support its operations. However, given the federal and local financial pressures outside of the University's control, the University continues to find creative solutions to balance revenues and expenses to ensure operational continuity and the achievement of long-term strategic initiatives.
- **Enrollment & Retention** are among the most significant strategic challenges facing the University because they directly affect tuition revenue, workforce development, and the University's long-term sustainability. UOG can improve enrollment, increase student retention, and strengthen its long-term sustainability by combining sound financial management with targeted recruitment, affordable education, strong student support, and programs aligned with Guam's workforce needs.



The **Dr. Lucio C. Tan Student Success Center** provides a One-Stop location of services to students in providing academic support, career development, financial aid, counseling, and a student hub with dining and collaboration spaces.



School of Engineering Building

The University of Guam is expanding its School of Engineering with the launch of a new Bachelor of Science in Construction Management degree program to commence in Fall 2026. UOG is also planning to launch a Bachelor of Science in Electrical Engineering in Fall 2027, increasing educational and career pathways for future engineers on the island.



Margaret Perez Hattori-Uchima School of Health Nursing Hub

The additional space will support hands-on learning, simulation training, and collaborative instruction designed to meet the growing demand for healthcare professionals on Guam and throughout the region.
