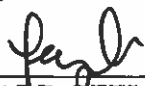

She explained that ASWB is responsible for examination registration and can provide guidance regarding available testing options, including remote administration and approved accommodations for ESL or other qualifying needs. 	ii. Evelyn Alicante – LCSW A. Lape discussed the applicant’s 16 CEUs focused on military life noted in the application for cultural competency. The applicant is requesting for cultural competency because our application requirement is specific to Guam’s diverse population. It was noted that the applicant explained her CEUs were based on her work as a Military and Family Life Counselor and asserted that the military community constitutes a significant and culturally diverse segment of Guam’s population, including active-duty service members, Department of Defense civilians, contractors, and their dependents. The Board reviewed the applicant’s written justification and considered whether the military-focused cultural competency training satisfied the intent of the Board’s cultural competency requirement. D. Calvo commented that the military community, particularly from the perspective of a military spouse, may represent a distinct cultural experience. However, D. Calvo noted that there is uncertainty regarding whether this experience would be classified as a separate culture for purposes of meeting the cultural competency requirement. A. Lape reviewed the requirements outlined in the Social Work Practice Act and the			Tabled, Pending Submission of CEU’s

		Board's Rules and Regulations. She noted that the cultural competency requirement is intended to address competency related to Guam's diverse population, including the various ethnicities and Pacific communities represented on the island. While the Board acknowledged and respected the applicant's submission regarding military cultural competency and recognized that the military community may represent a distinct culture, it was determined that this was not consistent with the intent of the cultural competency requirement. A recommendation was made for Ms. Alicante to complete four CEUs focused on cultural competency related to the Pacific region or Micronesia and resubmit the documentation for consideration. A. Lape noted that all other application requirements had been satisfied and that the cultural competency requirement was the only remaining item pending before the application could be reconsidered. <i>Motion to Table Pending Submission of CEUs: A. Lape; 2nd: D. Calvo.</i>			
		iii. Carol Anne Gordon – LCSW A. Lape brought a concern before the Board regarding the applicant's submitted continuing education requirements in relation to the Social Work Practice Act. It was reported that the applicant had submitted at least 16 cultural competency CEUs, 4.5 disability-related CEUs, and 4.5 ethics CEUs. The concern raised involved the ethics CEUs, as the certificates indicated that the training was provided through an ASWB-approved continuing education program rather than by the NASW, as specifically referenced in the Social Work Practice Act. A. Lape noted that ASWB and NASW are separate and independent organizations, prompting further discussion regarding whether the submitted ethics CEUs met the statutory requirement. The Board discussed that ethics CEUs from ASWB-approved providers rather than the NASW had been previously reviewed and not approved. The Board emphasized the importance of remaining consistent with prior decisions and agreed that the current matter should be handled in accordance with established practice.
