	<p><b>B. Temporary Licenses</b>  A discussion began that centered around the issuance of temporary licenses and the renewal process. Dr. Balajadia clarified that while applicants may have met the legal deadline for submission by December 31st, issues such as the publication deadline and the board's approval requirements complicated the process. Temporary licenses can be issued by the chairperson if an application is complete but cannot be processed in time for a board meeting. Dr. Miller inquired about the role of the board in scrutinizing applications, emphasizing the need for careful review and vigilance to ensure that only qualified and ethical individuals are licensed. Dr. Balajadia stressed the importance of the board's responsibility to protect the public from unscrupulous individuals, particularly in cases where applicants may attempt to bypass regulations. She expressed a commitment to ensuring the integrity of the licensing process and protecting the public interest. The conversation ended with a call for board members to take their responsibilities seriously and work together to uphold the law.</p>			Noted
