The **Guam Council on the Arts and Humanities [CAHA]** was created by Public Law 16-122 as Guam’s state arts agency. CAHA is charged with administering federal and local monies in support of the arts in Guam. Its role is to ensure that the arts in the community will grow and play a more significant part in the welfare and educational experience of our residents. With a small staff and limited resources, CAHA remains actively engaged in the arts and maintains a presence in the community. Whether it be through CAHA initiatives or through its collaborations with the public or private sector, the arts and culture are thriving on Guam.



**Our Performance - CAHA Programs**

**Grants Program:** CAHA awarded 19 grants totaling \$141,495.00 in FY 2023 to individuals and organizations for projects in various artistic disciplines encompassing arts education (1), folk arts (1), media arts (2), special projects (3), visual arts (6), with emphasis placed on programs that benefit the underserved community (6). Grant and fellowship awards supported projects such as apprenticeships, arts instruction and presentations in schools, musical and theatre productions, podcasts, recordings and video documentation, literary works and publications, cultural and art events and contemporary and traditional art exhibitions. **Art-in-Public Places a.k.a. Percent for the Arts**

Enacted in 1979 through Public Law 15-50, the Art in Public Places Program also known as the Percent for the Arts. The program targets both public and non-public development projects supported by either federal or government of Guam funds, as well as, those administered through Qualifying Certificates (QC) tax rebates, incentives, loans guarantee, bond financing or other subsidy arrangements. The program's purpose is to foster culture, arts and the development of local artists by which a portion for capital expenditures, specifically one percent (1%) of the construction, renovation or remodeling costs be set aside for the acquisition of works of art for public and non-public buildings and facilities or be given to the Guam Council on the Arts and Humanities Agency in lieu of the inclusion of arts.



The CAHA Art Gallery is a venue for local artists, organizations and schools to exhibit and showcase their arts, offering the people of Guam an opportunity to experience and enjoy their creativity. Eight exhibits were held in FY 2023 : 6 solo exhibits and 2 group showings. The gallery is located in the heart of Hagåtña on the second floor of the DNA Building.

The CAHA Art Bank Program significantly contributes to the support and promotion of visual, traditional, and contemporary artists by showcasing their artwork, thereby enhancing public awareness and appreciation of the arts. The CAHA collection comprises around 300 art pieces across diverse mediums, including acrylic, watercolor, oil, batik, wood carvings, and ceramics, represented in both two-dimensional and three-dimensional forms. These artworks are loaned to government agencies annually on a rotating schedule for exhibition and display within their facilities.

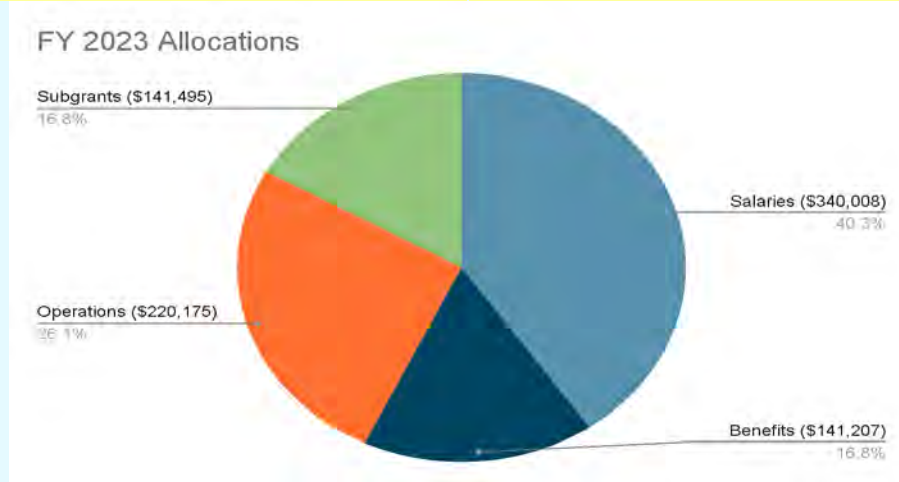

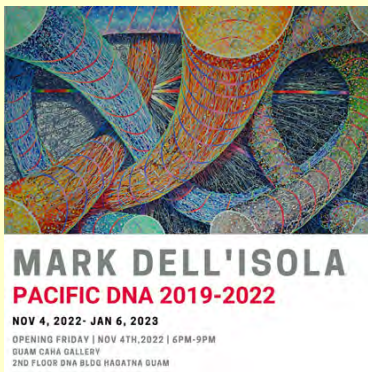
## Our Performance and Our Outlook

### Our Performance (continued)

#### Collaborative Partnerships and Specialized Initiatives

CAHA forges partnerships with various government entities, including the Guam Visitors Bureau, Guam Department of Education, University of Guam, and Department of CHamoru Affairs, as well as village mayors and non-profit organizations. The purpose of these collaborations is to ensure that all citizens have the opportunity to participate in and experience activities that incorporate arts or culture into their events. Furthermore, CAHA collaborates with businesses, financial institutions, and hotels to showcase artwork and traveling exhibitions in their establishments. These collaborative efforts are exemplified through events such as the Guam Micronesia Island Fair and the Annual Silbrasion Mes CHamoru.

CAHA has partnered with the Pacific Resources for Education and Learning (Hawaii) to host workshops for teachers. Additionally, the organization had hosted an exhibit by Pulitzer Winner Manny Crisostomo and held an informative workshop on the 13th Festival of Pacific Arts 2024 (FestPac) conducted by Dr. Judy Flores. CAHA also presented a special exhibit paying tribute to the late Master Ifit Wood Carver Robert Taitano. These partnerships and specialized projects demonstrate CAHA's commitment to providing diverse cultural experiences and opportunities for the community to engage with the arts.



### Moving Forward

- IN FY 2024, CAHA plans to:
- 1) Award grants to support arts programs & projects across all disciplines, with the aim of benefitting the local community.
  - 2) Increase its visibility & presence in the community.
  - 3) Take a proactive approach to the Art in Public Places Program, (Percent for the Arts Initiative).
  - 4) Provide more opportunities for public participation in the arts.
  - 5) Expand its artist database.
  - 6) Promote cultural preservation, identity & diversity.
  - 7) Strengthen existing partnerships & develop or establish new collaborations with the public & private sector.
