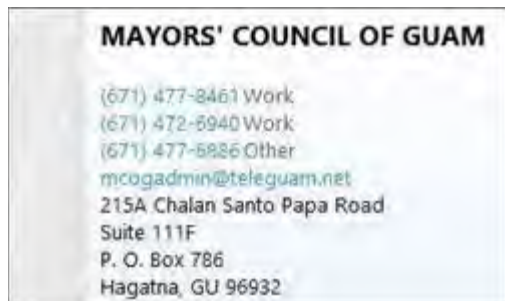

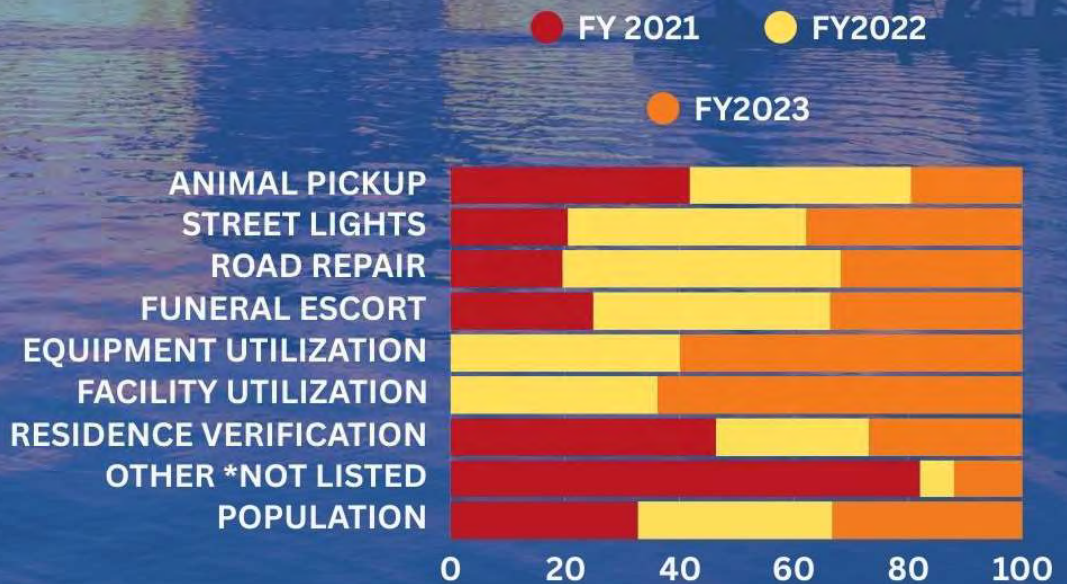

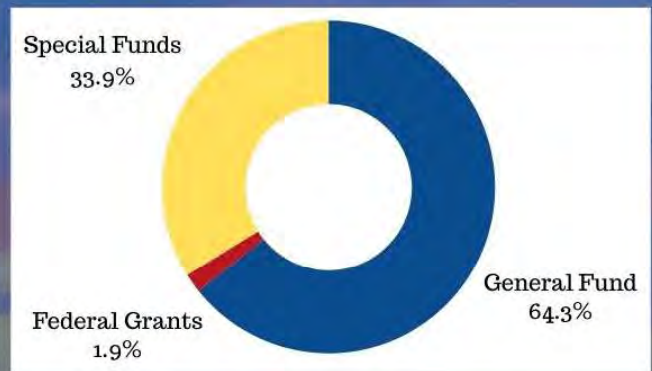

IMPACT OF TYPHOON MAWAR

The financial challenges faced by the Mayors' Council of Guam in FY 2023 are largely due to the devastating impact of Typhoon Mawar, which hit Guam with winds reaching approximately 140 mph, causing widespread damage and displacement. In the aftermath of the storm, the Mayors' Council was actively engaged in the response and recovery efforts, working alongside FEMA, SBA, and other federal agencies, local government agencies, and community organizations to address immediate needs for emergency repairs and housing for affected households.

As part of the recovery, MCOG prioritized providing assistance to vulnerable residents and ensuring their access to safe, sanitary, and secure homes. However, the unprecedented scale of the disaster created a significant strain on the Council's financial resources. The costs associated with disaster response, including the provision of emergency services, the coordination of debris removal, and repairs to public infrastructure, resulted in a negative financial outcome for the fiscal year.

Key challenges included delays in receiving adequate resources and equipment, which hindered MCOG's ability to effectively manage the recovery efforts. For instance, heavy equipment and other necessary resources were slow to arrive, and there were logistical bottlenecks, such as gas shortages and delays in clearing debris, which further compounded the financial strain. These challenges were particularly evident in every village, where ongoing issues with debris disposal and the maintenance of public spaces, including parks and sports fields, impacted the financial planning for the recovery.

Despite these obstacles, MCOG has continued to work diligently with various partners to expedite recovery and mitigate further financial strain. MCOG is committed to enhancing its internal processes to ensure that funds are allocated efficiently, and we continue to seek funding and support from both local and federal sources to aid in the recovery process.

Looking ahead, MCOG aims to rebuild its financial stability while maintaining its commitment to the residents of Guam. We are confident in our ability to recover from the financial challenges of FY 2023 and ensure that our communities are better prepared for future challenges.
