II. PROOF OF DUE NOTICE OF MEETING

Due publication of the five-day Notices of Meeting of the Judicial Council, as required under the Open Government Law, was published in the Guam Daily Post. Acknowledgments are on file.

III. DETERMINATION OF QUORUM

Chief Justice Torres began the roll call. Chief Justice Robert J. Torres, Justice F. Philip Carbullido, and Presiding Judge Alberto C. Lamorena III identified themselves. Justice Katherine A. Maraman and Judge Maria T. Cenzone were excused. This meeting determined a quorum with three (3) of the five Judicial Council members present during roll call.

IV. READING AND DISPOSAL OF MINUTES: June 19, 2025 Regular Meeting minutes.

Chief Justice Torres asked for a motion to approve the June 19, 2025 Regular Meeting minutes. Presiding Judge Lamorena made a motion to approve the minutes, Justice Carbullido seconded the motion. Chief Justice Torres called an oral vote. With no discussion, the Judicial Council members voted to approve the minutes, subject to correction.

V. OLD BUSINESS

A. Judiciary FY25 Remittances Pursuant to Applicable Law

Ms. Dianne Gudmalin, Finance Administrator, reported that the Judiciary continues to receive its scheduled biweekly allotment of \$1,652,000 for general operations under the FY2025 appropriation. According to Ms. Gudmalin, to date, approximately 81% of the total appropriated amount has been received with the most recent allotment deposited on July 1, and the next allotment expected on July 22.

B. eCourt and eSupervision Transition

Administrator of the Courts, Danielle T. Rosete, reported that the Judiciary continues to meet regularly with Journal Technologies and staff on the migration process. She shared that the first phase of the production data conversion is tentatively scheduled for the first week of August. Ms. Rosete explained that the subject matter experts will conduct data testing during this phase, with three total conversion phases planned. She added that once all phases are completed and approved, training for staff and judicial officers will be scheduled, followed by the system's official go-live.

Chief Justice Torres asked the Council to temporarily skip over Old Business Item C and move on to New Business Item C to recognize the mock trial representatives for their participation and achievements in the 2025 National High School Mock Trial Championship. With no objections, the Council agreed to proceed with New Business Item C.

C. Resolution, JC25 – Relative to Adopting a Training Program for Special Deputy Marshals

Ms. Rosete reported on the proposed training program for special deputy marshals, noting that school attendance officers (DOE) and tax officers (Rev & Tax) are limited to duties tied to their positions. She provided an example explaining that attendance officers may execute pickup orders in truancy cases but lack arrest powers and cannot execute criminal warrants and the training program complies with POST Commission requirements for Category 2 officers.

Council members discussed the possibility of pursuing legislation to expand the authority of special deputy marshals to assist with warrant execution under the supervision of the Court Marshal. It was agreed that the Chief Marshal, Chief Probation Officer, and Legal Counsel would review the proposal and report back within 60 days on its feasibility, statutory considerations, and potential parameters.

Justice Carbullido moved to adopt the resolution; Presiding Judge Lamorena seconded the motion. The Council unanimously adopted the resolution approving the training program for special deputy marshals.

VI. NEW BUSINESS

A. Resolution, JC25-012 – Relative to Commemorating the 50th Anniversary of the Guam Public Defender Service Corporation

The Council ratified Resolution JC 25-12, which had been previously signed and presented to the Public Defender Service Corporation in recognition of its 50th anniversary during the celebration held at the Dusit Thani.

B. Resolution, JC25- Relative to Ratifying Resolution No. JC25-012 Commemorating the 50th Anniversary of the Guam Public Defender Service Corporation

Presiding Judge Lamorena moved to approve the resolution to ratify JC25-12; Justice Carbullido seconded the motion. The resolution was unanimously approved.

C. Resolution, JC25- Relative to recognizing Mock trial Representatives for their participation and Achievements in the 2025 National High School Mock Trial Championship

Ms. Rosete presented a resolution recognizing Guam's 2025 High School Mock Trial participants for their accomplishments. Honorees included courtroom journalist Giada Meno,

courtroom artist Angel Samaniego, and the Okkodo High School Mock Trial Team. Chief Justice Torres pointed out that Samaniego placed third in the People's Choice category of the National Courtroom Artist Competition, and the Okkodo team earned the prestigious Larry Bakko Award for Professionalism and Civility, awarded by peers for integrity and fair play. Council members commended the students for their professionalism, skill, and representation of Guam, while Presiding Judge Lamorena emphasized the long-standing influence of the island's mock trial program, which has inspired many alumni to pursue law and leadership roles.

Justice Carbullido moved to approve the resolution; Presiding Judge Lamorena seconded the motion. The resolution was unanimously approved, followed by a photo session with the students, Council members, and program leaders.

D. Resolution, JC25- Relative to Proclaiming the Week of July 20-26, 2025 as Pretrial, Probation, and Parole Supervision Week

Chief Probation Officer Rossanna Villagomez-Aguon spoke on the resolution in recognition of the national observance of Pretrial, Probation, and Parole Supervision Week, scheduled for July 20–26, 2025. Following clarification on the resolution's wording, **Presiding Judge Lamorena moved to approve the resolution; Justice Carbullido seconded the motion, and the resolution was unanimously approved.**

E. Resolution, JC25- Relative to Commemorating the 75th Anniversary of the Organic Act of Guam and Recognizing Its Foundational role in the Establishment of Guam's Justice System

Chief Justice Torres explained that the resolution before Council will be presented during the 75th Anniversary of the Organic Act commemoration events beginning August 1, 2025. Chief Justice Torres indicated that an invitation to the anniversary activities, including a flag raising at Adelup and a naturalization ceremony, will be circulated to all judges. **The chief justice entertained a motion to approve the resolution. Presiding Judge Lamorena made a motion and Justice Carbullido seconded the motion. The Council approved the resolution recognizing the Organic Act's foundational role in establishing Guam's justice system.**

F. Notice of the Next Meeting (Thursday, August 21, 2025)

Chief Justice Torres noted that the Council's next meeting will be held on Thursday, August 21, 2025.

VII. COMMUNICATIONS

The Council received notice of events for the 75th Anniversary of the Organic Act of Guam, including flag raisings, ceremonies, exhibits, and festivities throughout August, with invitations to be circulated to all judicial officers.

VIII. PUBLIC COMMENT

A. Guam Bar Association Board (GBA) – President’s Report

Mr. Phillip Tydingco appeared on behalf of the Guam Bar Association (GBA) Board of Governors to share announcements and updates. He thanked the Judiciary leadership for the opportunity to report and highlighted several upcoming events, a national convention, and survey results of GBA membership regarding pending legislation.

- Respondents were divided on whether both AG and Public Prosecutor should be elected:
 - 54% opposed dual elections.
 - 45% supported dual elections.

Mr. Tydingco concluded his report by thanking the Judiciary for the opportunity to present on behalf of the GBA.

IFIK President Jesse Franquez was excused due to military duty. No report was provided; a report will be given at the next meeting.
