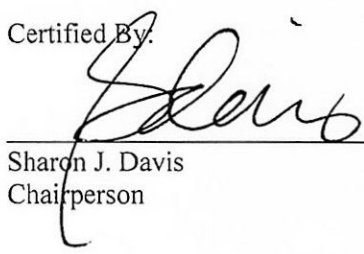
WHEREAS, the GMHA Board of Trustees has reviewed the list of new fees and found the same to be in order; now therefore be it,

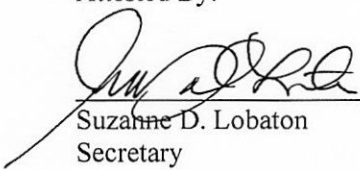

Opening Remarks	On behalf of the GMHA Board of Trustees, the Hospital Administrator/CEO, and the GMHA employees, Ms. Hechanova welcomed the public to join this public hearing via Zoom Video Conferencing. III.	Purpose of the Public Hearing	Ms. Hechanova cited the enactment of Public Law 26-66 in December 2001, which removed the rate-setting jurisdiction from the PUC and gave it to the GMHA Board of Trustees and the Guam Code Annotated 10GCA §80109(c) that gave the authority to the Hospital to set its rates. In compliance with the Administrative Adjudication Law and further Guam Code Annotated directives, the Hospital published in the Guam Daily Post the announcement of this public hearing. The Hospital also posted the announcement of this public hearing on the GovGuam Public Notices Portal to notify the public. The Hospital also sent the notice of this public hearing via electronic mail and facsimiles to various news media organizations and via electronic mail to the Governor's Office, Lieutenant Governor's Office, the Congressman's Office, and to our elected Senators of the 38 th Guam Legislature. In addition, letters were sent to the third party payers via electronic mail inviting them to join this public hearing via Zoom Video Conferencing. The Hospital also posted the Notice of Public Hearing and the list of new fee items on its official website as mandated by public law.		Informational

Ms. Taisacan responded that the professional fees are newly created fees for the Hospital. We used the CPT code in the PFR and added to our Charge Master. Mr. Campiillo further verified if these professional fees were different from the established PFR. Ms. Taisacan confirmed that they were not. 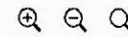

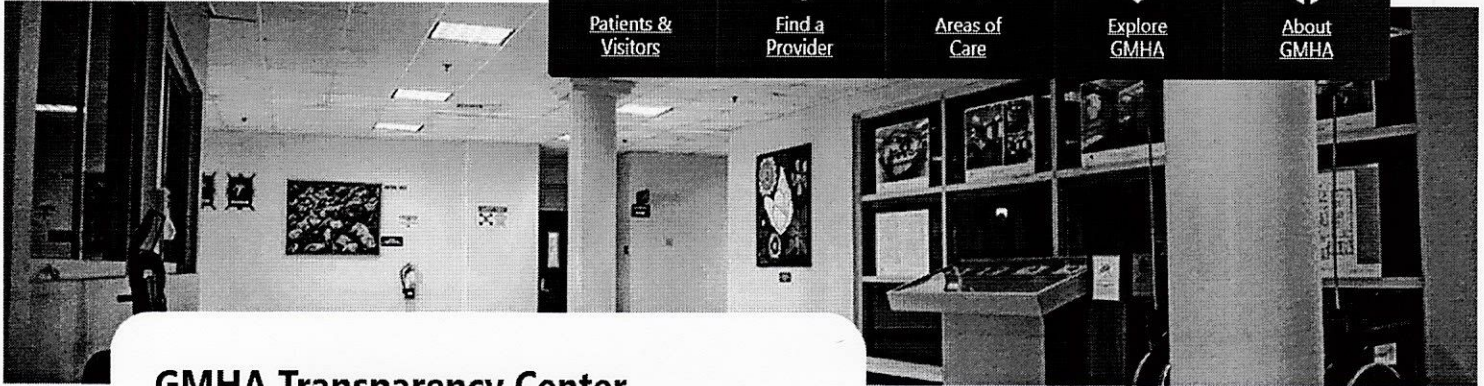

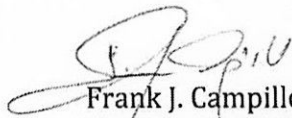

We appreciate the opportunity to provide this written testimony regarding the Guam Memorial Hospital Authority's (GMHA) public hearing held on June 16, 2026, concerning the hospital's new proposed fees and charges.

During our review of the updated fee schedule, we noted that GMHA continues to adjust professional fees using the established Professional Fee Rate (PFR) methodology. However, we also observed that GMHA is proposing new professional fee rates for certain services that already have existing PFR-based rates. In some cases, these proposed rates are higher than the current PFR-adjusted amounts, resulting in increases beyond the standard annual PFR adjustment.

We respectfully request clarification on why new professional fee rates are being established for services that already have existing PFR-based rates, and we suggest that GMHA retain its current pricing methodology for these services. We appreciate GMHA's transparency in conducting this public hearing and respectfully ask for this clarification so we can better understand the rationale behind the proposed fee changes. Thank you for the opportunity to provide this testimony and for GMHA's continued commitment to engaging the community on matters affecting healthcare services.

Thank you for your comments and for the opportunity to clarify the Professional Fee Services identified in the Summary of New Fee Items and Services.

The Professional Fee Services identified in the Summary of New Fee Items and Services reference CPT codes that already exist in the GMHA Charge Master, and their professional fee rates are based on the established Professional Fee Reference (PFR) at the 50th percentile. Separate departmental charge codes were created for departments such as Cardiology, Gastroenterology, and other hospital-based clinics to accurately capture and distinguish departmental revenue for financial reporting purposes. Although assigned different departmental charge codes, these services utilize the same CPT code and the same PFR-based professional fee. Therefore, there is no fee difference.

Similarly, the Technical Fee Services may reference CPT codes that already exist in the GMHA Charge Master; however, separate departmental charge codes were established to accurately capture technical service revenue by department. The technical fee rates are based on the applicable (CMS) Ambulatory Payment Classification (APC) payment rates, which reflect the hospital resources required to furnish the service, including equipment, supplies, facility overhead, and clinical support personnel. As a result, while the CPT code may be the same, the technical charge code and corresponding fee are established independently based on the applicable CMS APC payment rate.

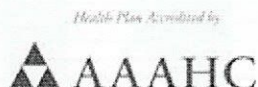
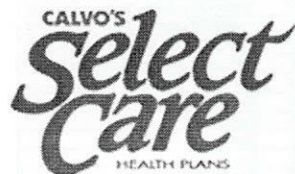
