*Håfa Adai* Mr. Speaker,

Bills Nos. 185-38, 189-38, and 190-38 are measures modernizing the administration of elections, strengthening campaign finance oversight, and providing clarity and consistency for voters, candidates, and election officials.

Bill No. 185-38 provides the Guam Election Commission (GEC) with increased operational flexibility by reducing the appointment window for registration clerks before a general election from forty-five (45) days to twenty-one (21) days. The bill also harmonizes registration deadlines by adjusting the statutory registration period, for people to register to vote, to fifteen (15) days before an election, ensuring consistency across volunteer, online, motor voter, and district

registration processes. Striking an appropriate balance between access and administrative certainty.


Bill No. 189-38 updates the GEC's campaign finance rules adopting revised regulations and reporting forms, clarifying disclosure and recordkeeping obligations, and aligning administrative rules with statutory requirements. Bill 189-38 further establishes clear procedures for report reviews, deficiency notices, cure periods, and graduated penalties, while codifying the investigative authority, subpoena power of the GEC, as well as its power to conduct appeals, and issue advisory opinions. These reforms modernize campaign finance administration promoting transparency, fairness, and accountability in Guam's elections.

Bill No. 190-38 adopts an updated 2025 Guam Election Manual. The updated manual establishes and publishes the GEC's digital and electronic processes (online registration, early in-office voting, and expanded public access to election information). The manual also clarifies candidate filing and campaign finance coordination requirements under the new statutory frameworks, while standardizing procedures for complaints, investigations, and enforcement. Bill 190 updates definitions, aligns timelines and monetary thresholds with current law, providing greater clarity for election workers, candidates, and the public.

Taken together, these measures modernize the electoral framework and equip the Guam Election Commission with the clear authority and tools to continue to administer elections effectively.

For these reasons, I sign Bill Nos. 185-38 (COR), 189-38 (COR), and 190-38 (COR) into law as ***Public Law Nos. 38-87, 38-88, and 38-89***, respectively.



**AN ACT TO REPEAL AND REENACT CHAPTER 3, TITLE 6, GUAM ADMINISTRATIVE RULES AND REGULATIONS, AND ADOPT THE ATTACHED EXHIBIT A, EXHIBIT B AND EXHIBIT C, RELATIVE TO UPDATING THE GUAM ELECTION COMMISSION ELECTION CAMPAIGN CONTRIBUTIONS AND EXPENDITURES RULES AND REGULATIONS AND REPORT FORMS.**

**BE IT ENACTED BY THE PEOPLE OF GUAM:**

**Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds

that, in accordance with 5 GCA § 9303 (a), the Guam Election Commission (GEC)

1 proposed updates to Chapter 3, Title 6 of the Guam Administrative Rules and  
2 Regulations, which were approved by the Commission during its Board meeting held  
3 on April 14, 2025. In compliance with the Guam Administrative Adjudication Law  
4 (5 GCA Chapter 9), the approved updates were subsequently submitted to the Office  
5 of *I Magan'hågan Guåhan* and the Office of the Attorney General on June 27, 2025.  
6 Following their review, both offices approved the proposed updates. The Office  
7 of the Attorney General found the revisions to be constitutional, consistent with  
8 statutory authority, and in substantial compliance with the Guam Administrative  
9 Adjudication Law. While the agency record met most requirements including public  
10 hearing notices, transcripts, and cost impact documentation, it lacked proof of  
11 website posting and advance availability of the cost assessment. Despite these  
12 technical gaps, the Attorney General concluded that GEC substantially complied with  
13 the law and recommended either holding another public hearing or proceeding with  
14 approval. The approved updates were later transmitted to the Office of the Speaker  
15 on September 2, 2025. Upon receipt, the proposed updates were referred to  
16 the Committee on Economic Investment, Military Buildup, Regional Relations,  
17 Technology, Regulatory Affairs, Justice, Elections, and Retirement on September 11,  
18 2025. In accordance with 5 GCA § 9303 (b), the Committee introduced the  
19 measure on September 12, 2025, and subsequently scheduled a public hearing to  
20 receive testimony on the proposed updates to Chapter 3, Title 6 of the Guam  
21 Administrative Rules and Regulations.

22 Therefore, it is the intent of *I Liheslaturan Guåhan* to formally adopt the  
23 revised rules and regulations, along with the attached Exhibits A, B, and C.

24 **Section 2.** Chapter 3, Title 6, Guam Administrative Rules and Regulations,  
25 is hereby *repealed* and *reenacted* to read:

20      **§ 3101.     Purpose and Scope of Rules.**

21       The purpose and intent of these rules and regulations are to implement

22   Chapter 17 of 3 GCA, as amended, cited as Election Campaign Contributions &

23   Expenditures.

24      **§ 3102.     Contents of Report.**

25       Pursuant to 3 GCA Chapter 17, and the Administrative Adjudication Law,

26   the Organizational Report, Election Campaign Contributions and Expenditures

27   Report forms, and the Report for Dissolution, and accompanying instructions



thereto, are herein incorporated as Appendix A, B, and C, respectively, to these rules and regulations. Said appendices, not in conflict or inconsistent with 3 GCA Chapter 17 shall govern the contents of reports filed pursuant to the Election Campaign Contributions and Expenditures Chapter.

**§ 3103. Specific Instructions for Organizational Report and Election Campaign Contributions and Expenditures Report.**

(a) Name of Candidate, Committee, or Party. The name of a candidate or the official name of a committee, political party, or association should be clearly indicated.

(b) Elected Office Sought, Question, or Issue. The Organizational Report shall clearly indicate:

(1) If a candidate or committee directly associated with a candidate, the elected office sought. The elected office indicated on the Organizational Report shall be effective only for the election for which the individual is seeking nomination or election to office.

(2) If a question or issue committee, the question or issue(s) for which the organization intends to receive contributions and make expenditures for.

(c) Treasurers. Each organization shall appoint one (1) official campaign treasurer and may appoint up to five (5) deputy campaign treasurers. Each treasurer shall be authorized to receive contributions or make expenditures on behalf of the candidate, committee, or political party. If a candidate wishes to act as a campaign treasurer, it must be so noted on the Organizational Report and all reports filed in accordance with 3 GCA Chapter 17 must be certified by the candidate in his/her capacity as both the candidate and a campaign treasurer.

(d) Chairpersons. The chairperson and deputy chairperson shall serve as the two (2) highest ranking officials of the organization.

1           (e)   Financial Institutions. Each organization that intends or subsequently  
2 receives monetary contributions shall establish a separate account at any number of  
3 financial institutions. Funds received by the organization shall not be  
4 commingled with personal funds of the candidate, or any other individual, and a  
5 candidate committee shall nonetheless establish an account separate from his/her  
6 personal one for the purpose and duration of the campaign. Any organization that does  
7 not intend, and subsequently does not receive, any monetary contributions shall not  
8 be required to establish an account at a financial institution.

9           Each organization shall keep a comprehensive financial record of all  
10 transactions for all financial institutions it does business with. A detailed  
11 accounting of all transactions, safety deposit boxes, deposits, loans, and all  
12 applicable account numbers shall be reported to the Commission.

13           All monetary contributions shall be deposited only into the account(s)  
14 indicated on the Organizational Report within 5 business days of receiving said  
15 contributions.

16           (f)   Contributions.

17           (1)   Cash Contributions. All monetary contributions shall be deposited  
18 in the committee's financial institution stated on the Organizational Report  
19 within 5 business days of receiving said contributions. The date of deposit and  
20 source of deposit shall be identified for all monetary contributions received  
21 by the candidate or committee. Each candidate or organization shall establish  
22 an itemized record showing the names, addresses and dates of every  
23 individual who donates a cumulative amount of more than one hundred  
24 dollars (\$100.00). No candidate or organization shall accept more than two  
25 hundred fifty dollars (\$250.00) in cash without issuing a receipt and keeping  
26 a record of the transaction.



1           Each candidate or organization shall report the names, dates and  
2 addresses of each individual who has donated a cumulative amount of more  
3 than one hundred dollars (\$100.00) to the campaign.

4           (2) Aggregate Contributions. Each candidate or organization shall  
5 report fundraising activities, wherein the cost per person or ticket is not more  
6 than twenty-five dollars (\$25.00). Each such aggregate contribution shall be  
7 reported by the cash amount received, description of the means (e.g. birthday,  
8 rallies, etc.), method (e.g. cost of one ticket, etc.), place and date. If the  
9 fundraising activity occurred over a period of time and not on a specific date,  
10 the candidate or organization shall report the first date on which the  
11 fundraising activity took place.

12           (3) Other Cash Contributions. All other monetary contributions  
13 received and not reported in the aforementioned categories shall be  
14 reported in accordance with this section. Each such contribution shall be  
15 reported by the cash amount received, description of the means (e.g.  
16 birthday, rallies, etc.), method (e.g. cost of one ticket, etc.), place, and date.

17           (4) Non-monetary Contributions. Non-monetary contributions are  
18 all gifts, subscriptions, cancellations of debt, contracts, promises or  
19 agreements to make a contribution other than cash, or the payments by any  
20 person other than a candidate or committee, or compensation for personal  
21 services of another person, which are rendered to the candidate or  
22 committee without charge or at an unreasonably low charge, or a discount not  
23 offered to any other candidate or committee other than volunteer campaign  
24 services. All non-monetary contributions shall be reported based on the fair-  
25 market value of the contribution exceeding one hundred dollars (\$100.00),  
26 along with the name and address of the donor, nature of contribution and date.



1           (5) Earmarked Contributions. Earmarked contributions are all cash  
2 or non-monetary contributions received by the candidate or organization on  
3 the condition that the funds are contributed to only certain candidates, issues,  
4 or questions.

5           All earmarked contributions shall be reported by the total amount  
6 earmarked, the ultimate receipt of earmarked funds, the name and address of  
7 the donor, the description of the contribution, date, and name(s) of sharing  
8 candidates, issues, or questions.

9           (g) Expenditures. Means any purchase, transfer of money or anything of  
10 value, promise or agreement to purchase or transfer money or anything of value,  
11 payment incurred or made, consumption of any non-monetary contribution, or the  
12 payment by any person other than a candidate or committee, of compensation for the  
13 personal services of another person which are rendered to the candidate or  
14 committee for the purpose of influencing a candidate, committee, or political party's  
15 campaign.

16           (1) Funds Expended. Every candidate or organization shall record  
17 all cash transactions spent in aid of their campaign. The record shall be an  
18 itemized accounting of the cash amount spent, name and address of the  
19 payee, and the date and purpose for each expenditure.

20           (2) Incurred Expenditures. Every candidate or organization shall  
21 make a detailed accounting of all promises or agreements to purchase. The most  
22 current balance of all monetary liabilities (short and long term) shall be  
23 recorded in accordance with this section.

24           (3) Non-monetary Expenditures. Non-monetary expenditures are  
25 gifts, consumption or use of non-monetary contributions, promises or  
26 agreements to make an expenditure other than cash, or payments, by any  
27 person other than a candidate or committee, or compensation for the

1 personal services of another person, which are rendered to the candidate or  
2 committee without charge other than volunteer campaign services.

3 (4) Earmarked Expenditures. All cash or non-monetary expenditures  
4 made by the candidate or organization on the condition that funds be  
5 expended for certain candidates, issues, or questions.

6 All earmarked expenditures shall be reported by the total amount  
7 earmarked, the ultimate receipt of earmarked funds, the name and address of  
8 the donor, the description of the contribution, date and name(s) of sharing  
9 candidates, issues, or questions.

10 (5) Transfer of Campaign Contributions. Any candidate or committee  
11 that draws upon campaign funds to contribute to another candidate or  
12 committee shall report the expenditure to include the name and address of the  
13 candidate or committee the funds were expended to, the purpose of the  
14 expenditure (e.g. birthday fundraiser, ½ payment for billboard ad, etc.),  
15 and the date the expenditure was made. Any transfer of campaign  
16 contributions from one candidate or committee to another shall nonetheless  
17 be in accordance with 3 GCA § 17110.

18 **§ 3104. Recordkeeping.**

19 All candidates and committees shall be required to keep a detailed accounting  
20 and comprehensive record of all receipts and checks issued and received, deposit slips  
21 and bank statements for the candidate, committee, or organization and shall provide  
22 the records to the Commission upon request.

23 **§ 3105. Amending Reports.**

24 Any candidate, committee or organization may amend a report already  
25 submitted, and the amended report will stand in lieu of the report being corrected,  
26 provided that the amended report is certified pursuant to 3 GCA § 17103.

27 **§ 3106. Electronic Reports.**



1 All candidates and committees shall be required to submit an electronic  
2 version of each certified report in the format prescribed by the Commission.

3 **§ 3107. Temporary Acceptance or Rejection of Reports; Opportunity**  
4 **to Cure Deficiencies.**

5 (a) Submission and Review. All campaign finance reports required under 3  
6 GCA Chapter 17 shall be submitted by the deadlines prescribed in law or regulation  
7 and must contain all required information, including certifications and supporting  
8 details.

9 (b) Temporary Rejection of Reports. The Commission shall reject a report  
10 for filing under the following conditions:

11 (1) The report lacks the required certification(s) under 3 GCA §§  
12 17103 and 17114;

13 (2) The report is materially incomplete, omits required schedules, or  
14 is not signed by the candidate, treasurer, or party representative;

15 (3) The report is submitted in a format not authorized by the  
16 Commission.

17 The Commission shall notify the filer in writing of the reason for rejection  
18 within five (5) business days of submission.

19 (c) Temporary Acceptance with Notice of Deficiency. If a submitted report  
20 contains errors or minor deficiencies that do not render it invalid, the Commission may  
21 provisionally accept the report for the purpose of compliance deadlines, provided  
22 that:

23 (1) The filer is notified in writing of the deficiency; and

24 (2) The filer is provided a cure period of seven (7) business days to  
25 submit a corrected report and written explanation.

26 (d) Cure Period and Good Faith Effort.

27 (1) If the deficiency is corrected within seven (7) business days, and



1 a written explanation is submitted, no fine shall be imposed.

2 (2) If the deficiency is corrected after seven (7) business days, a fine  
3 of \$50 per business day shall apply from the eighth day forward  
4 until the correction is made.

5 (3) If no correction or written explanation is received within fifteen  
6 (15) business days of the notice, the filer shall be deemed  
7 noncompliant and shall be subject to a fine of \$500.

8 (e) Appeal. A filer may appeal the determination of a material deficiency  
9 or rejection by submitting a written appeal to the Commission within five (5)  
10 business days of receiving notice. The Commission shall issue a written  
11 decision within ten (10) business days of receipt of the appeal.

12 (f) Final Determination. A report shall not be deemed "filed" for statutory  
13 or regulatory purposes until it has been accepted without material deficiency or  
14 accepted provisionally with all deficiencies cured within the applicable timeframe.

15 **§ 3108. Dissolution of Organizations.**

16 (a) When to dispose after dissolution. All candidates and committees, with  
17 the exception of political parties, shall dispose any organizational residual  
18 contributions by the twentieth (20<sup>th</sup>) day after activities cease for the campaign for  
19 which the Organization was established.

20 (b) How to dispose. All candidates who withdraw or cease to be candidates,  
21 or committees directly associated with these candidates, or persons who receive  
22 contributions but fail to file for nomination, or committee or parties which  
23 discontinue their campaign activities outlined in 3 GCA Chapter 17, shall return any  
24 residual contributions to the political party of the person or candidate or to the  
25 campaign committee of a person of the same party who is a candidate for the same  
26 office as the person who has ceased to receive contributions or to be a candidate.  
27 Any organization or candidate not affiliated with a political party shall escheat any

1 residual contributions to the Government of Guam. Each candidate, committee, or  
2 organization shall file their disposition with the Guam Election Commission using  
3 the Report for Dissolution form. This report shall disclose the manner in which all  
4 funds were expended and/or returned.

5 (c) Upon filing their Report for Dissolution, each candidate, committee, or  
6 organization shall:

7 (1) If seeking reelection, submit a bank account statement indicating  
8 the ending balance at the time in which the Report for Dissolution is being  
9 filed; or

10 (2) If not seeking reelection, submit a bank account statement  
11 indicating that the bank account has been closed and the ending balance at the  
12 time in which the Report for Dissolution is being filed.

13 **§ 3109. Complaints and Investigation**

14 (a) Investigation. The Guam Election commission may conduct  
15 investigations on the alleged violation and may subpoena any person, documents, or  
16 relevant materials pertaining to the case.

17 (b) Appeal of Findings. The appeal of any finding made by the Guam  
18 Election Commission relative to the filing of a report may be made by an  
19 interested party. The complaint shall be in writing and shall be signed under oath by  
20 the complainant.

21 (c) Confidential. Until the determination of probable cause by the Election  
22 Commission, all proceedings, including the filing of the complaint, investigation, and  
23 hearing shall be confidential, unless the person complained against requests an open  
24 session. In the event the Election Commission determines that probable cause does  
25 not exist, the complaint shall be dismissed, and the entire records of the proceedings  
26 shall be kept confidential at the option of the person complained against.



1 (d) Informal Hearing. All interested party(s) shall be granted an informal  
2 hearing within fifteen (15) days from receipt of a complaint, on any matter  
3 relevant to the filing of the report.

4 (e) Formal Hearing. Should an informal hearing prescribed in § 3104 (d)  
5 of this chapter fail to resolve the matter, a formal hearing shall be granted within  
6 twenty (20) days thereafter.

7 **§ 3110. Advisory Opinions**

8 (a) Purpose. Any person may request a written advisory opinion from the  
9 Guam Election Commission (GEC) regarding the application or interpretation of any  
10 provision under Chapter 17 of Title 3 Guam Code Annotated or any rule adopted  
11 thereunder. Advisory opinions are intended to promote voluntary compliance  
12 and to provide clarity on legal obligations relating to campaign finance activity.

13 (b) Submission of Request. Requests must be submitted in writing and must  
14 include:

- 15 (1) the name and contact information of the requester;
- 16 (2) a complete and accurate statement of all relevant facts;
- 17 (3) the specific legal question or regulation at issue; and
- 18 (4) any documents or supporting material necessary for evaluation.

19 (c) Timeline for Issuance. Upon receipt of a complete request, the  
20 Commission shall adhere to the following timeline:

- 21 (1) Acknowledge receipt within three (3) business days;
- 22 (2) Complete a legal review and prepare a draft advisory opinion  
23 within fifteen (15) business days;
- 24 (3) Finalize and adopt the advisory opinion by majority vote of the  
25 Commission within thirty (30) calendar days of receipt of the request;
- 26 (4) Issue the final advisory opinion to the requester and publish it  
27 within three (3) business days of adoption.



1 (d) Legal Effect.

2 (1) A person who reasonably and in good faith relies on a  
3 published advisory opinion issued by the Commission shall be deemed to be  
4 in compliance with the applicable provision of law, provided the material  
5 facts are the same as those presented in the request.

6 (2) Advisory opinions shall not be legally binding in a court of law  
7 but shall be given deference by the Commission in any enforcement action.

8 (3) Advisory opinions may be modified or rescinded prospectively  
9 by majority vote of the Commission. Notice of such modification shall be  
10 publicly posted.

11 (e) Expedited Opinions. The Commission may issue an expedited advisory  
12 opinion within ten (10) business days upon a showing of urgency related to upcoming  
13 campaign activity or election deadlines. A written justification for the expedited  
14 review must be submitted with the request.

15 (f) Public Archive. The Commission shall maintain an online archive of  
16 all final advisory opinions, indexed by topic, date, and statutory reference.  
17 Advisory opinions shall be public records, unless the Commission determines that  
18 publication would violate privacy or confidentiality laws.

19 **§ 3111. Review of Reports.**

20 The Guam Election Commission shall establish a standard of review and  
21 perform its review of all campaign reports submitted by said standard. The  
22 Commission's review of each candidate, committee, and organization shall  
23 remain confidential until the completion of review. If the Commission finds that the  
24 candidate, committee, or organization had committed any violation of Chapter  
25 17, said violations shall be reported to the Board of Commissioners and the candidate,  
26 committee, or organization shall be subject to the schedule of fines specified in § 3110  
27 under the authority of 3 GCA § 17102 (h).

1           **§ 3112.       Hearing Procedures and Timelines for Enforcement Actions.**

2           (a)   Applicability. This section governs all hearings conducted by the Guam  
3 Election Commission (GEC) relating to enforcement of campaign finance laws  
4 under 3 GCA Chapter 17, including fines, deficiencies, violations, or challenges  
5 arising from the filing or review of reports.

6           (b)   Notice of Violation. If the Commission determines there is a potential  
7 violation, it shall issue a written Notice of Violation to the respondent, stating:

- 8                   (1)   The nature of the alleged violation;  
9                   (2)   The facts or findings supporting the determination;  
10                  (3)   The proposed fine or corrective action;  
11                  (4)   The right to request an informal or formal hearing;  
12                  (5)   The deadline to request a hearing, which shall be ten (10) business  
13 days from receipt of notice.

14          (c)   Informal Hearing.

15                  (1)   If requested, an informal hearing shall be scheduled within  
16 fifteen (15) business days of the request.

17                  (2)   The informal hearing shall be non-adversarial, and parties  
18 may appear with or without counsel.

19                  (3)   The hearing officer (or designated GEC staff) may attempt  
20 to mediate or resolve the matter.

21                  (4)   A summary of the informal hearing shall be recorded and placed  
22 in the Commission's enforcement file.

23          (d)   Formal Hearing.

24                  (1)   If the matter is not resolved informally, a formal hearing shall be  
25 scheduled within twenty (20) calendar days following the conclusion of the  
26 informal process, or upon direct request by the respondent.



1           (2) The respondent shall be given at least ten (10) calendar days'  
2 written notice of the date, time, and place of the hearing.

3           (e) Due Process Rights. At the formal hearing, the respondent shall have  
4 the right to:

- 5           (1) Be represented by counsel;
- 6           (2) Present evidence and witnesses;
- 7           (3) Cross-examine witnesses;
- 8           (4) Submit written legal or factual arguments;
- 9           (5) Receive a written decision based on the record.

10          (f) Hearing Record. All formal hearings shall be recorded or transcribed,  
11 and the record shall include all documents, pleadings, exhibits, and the decision of  
12 the Commission. The record shall be retained in accordance with GEC  
13 recordkeeping policy.

14          (g) Commission Decision. The Commission shall issue a written decision  
15 within fifteen (15) business days after the formal hearing concludes. The decision  
16 shall:

- 17           (1) Include findings of fact and conclusions of law;
- 18           (2) State whether the violation is sustained;
- 19           (3) Specify any fine, corrective action, or dismissal;
- 20           (4) Be served upon the respondent by certified mail or personal  
21 delivery.

22          (h) Finality and Appeal. A final decision by the Commission may be  
23 appealed pursuant to the procedures set forth in the Administrative Adjudication  
24 Law, 5 GCA § 9240, et seq., within the time period provided by law.

25          (i) Extensions and Continuances. Upon good cause shown, the Commission  
26 may grant one or more continuances of the deadlines provided herein, provided  
27 such extensions do not prejudice the rights of the respondent.

1           **§ 3113.       Exceeding Contribution Limits.**

2           (a)   Contribution Limits. No person shall make aggregate contributions in  
3   excess of one thousand dollars (\$1,000.00) to any one (1) candidate, candidate  
4   committee, or agent in a calendar year for a primary election, and no person shall  
5   make aggregate contributions in excess of one thousand dollars (\$1,000.00) for a  
6   general or special election. A primary and a general election are considered  
7   separate elections.

8           (b)   Responsibility to Monitor. Each candidate or committee treasurer is  
9   responsible for monitoring and aggregating all contributions received from each  
10   donor during each election to ensure compliance with the above limits.  
11   Contributions must be tracked cumulatively across all reporting periods for the  
12   election.

13          (c)   Rejection or Return of Excess Contributions. If a candidate or  
14   committee receives a contribution that exceeds the legal limit:

15               (1)   The excess portion of the contribution shall be returned to the  
16   donor within five (5) business days of identification;

17               (2)   A written explanation and copy of the return transaction (e.g.,  
18   check, receipt) shall be filed with the Guam Election Commission (GEC)  
19   within ten (10) business days of the return.

20          (d)   Treatment of Non-Monetary Contributions. The fair market value of  
21   any non-monetary contribution shall be included in calculating whether the  
22   contribution limit has been exceeded. Discounts or services provided at below-  
23   market value may be deemed contributions unless demonstrably offered on equal  
24   terms to the general public.

25          (e)   Violations and Penalties. Violations of this section are subject to the  
26   following fines, pursuant to 3 GCA § 17113 and the fine schedule adopted under 3  
27   GCA § 17102(h):



Excess Amount	Fine Imposed
\$1 to \$250	\$100
\$251 to \$500	\$200
\$501 to \$1,000	\$350
\$1,001 to \$3,000	\$500
\$3,001 to \$4,999	\$750
\$5,000 or more	\$1,000

Fines may be imposed on both the donor and the recipient committee. The Commission may also order the escheatment of any unreturned excess contributions to the Government of Guam.

(f) Exception – Good Faith Reliance. No fine shall be imposed if a candidate or committee can demonstrate to the Commission’s satisfaction that:

- (1) The excess contribution was received due to a bona fide clerical or reporting error;
- (2) The contribution was returned promptly upon discovery; and
- (3) The committee had a system in place for tracking contributions.

(g) Notification and Appeals. The Commission shall notify the candidate or committee in writing of any violation and proposed fine. The candidate or committee may submit a written appeal or request a hearing within ten (10) business days of receiving such notice.

#### **§ 3114. Fines.**

Any person, corporation, organization, or association who willfully violates any provisions in 3 GCA Chapter 17 shall be fined in accordance with the schedule of fines stipulated herein. Fines shall be administered by the completion of each quarterly review and shall only be imposed on offenses for which the candidate or committee has been given an initial written notification via certified mail

1 relative to the specified offense. In the case of a candidate committee, the fine(s)  
2 shall be jointly owed by the candidate and named treasurer(s). For all other  
3 committees, the fine(s) shall be jointly owed by the named treasurer(s) and  
4 chairman. Fines collected under this section shall be payable to the Treasurer of  
5 Guam to be deposited into the Guam Election Commission revenue account.

  - ii. All Other Committees: the GEC shall not receive reports that are not certified as correct by the party, or committee treasurer, or the deputy treasurer, or the chairman, thereof, in that order.
2. The GEC may accept a report pending the respective certification of the candidate, treasurer, and/or chairman upon written request if they are physically unable to certify a report, provided that the report is certified prior to the GEC's quarterly review of reports.

**§ 3115. Procedures for Documenting Efforts to Identify Donors prior to Escheatment.**

(a) Duty to Attempt Donor Identification. Before any campaign contribution may be escheated to the Government of Guam due to donor anonymity or excess contribution violations, the candidate, committee, or treasurer must make a good faith effort to identify the donor and return the contribution.

(b) Documented Steps Required. The following steps, at a minimum, shall be taken and documented by the candidate or committee in attempting to identify an anonymous donor or return excess contributions:

(1) Review of Records: Examine all contribution logs, sign-in sheets, event attendance lists, and online payment receipts for any indication of the donor's identity.

(2) Bank Inquiry: If the contribution was made by check, money order, or other traceable instrument, contact the financial institution to determine the name associated with the instrument, to the extent permitted



1 by law.

2 (3) Public Notice (Optional for Contributions  $\geq$  \$250): If internal  
3 records do not yield identifying information and the contribution exceeds  
4 two hundred fifty dollars (\$250.00), the candidate or committee may  
5 post a notice on their campaign website or social media account requesting  
6 the donor to come forward.

7 (4) Attempted Return: If partial identifying information (e.g., first  
8 name or initials) is available, attempt to return the funds via available  
9 mailing address, email, or contact number.

10 (c) Required Documentation. The candidate or committee must prepare and  
11 retain a written memorandum outlining:

12 (1) The amount and date of the contribution;

13 (2) A description of the form of contribution (e.g., cash, check,  
14 online);

15 (3) Each step taken to identify the donor;

16 (4) The result of each step;

17 (5) Whether the contribution was ultimately returned or escheated;

18 (6) A copy of any public notice or correspondence related to the  
19 return.

20 (d) Submission to GEC. If the contribution cannot be returned, a copy of  
21 the written memorandum, along with the escheated amount payable to the  
22 Treasurer of Guam, must be submitted to the Guam Election Commission within  
23 fifteen (15) business days of concluding the identification efforts.

24 (e) Escheatment. If the donor cannot be identified after completion of the  
25 above process, the funds shall be escheated to the Government of Guam in  
26 accordance with 3 GCA § 17111(c). No such contribution shall be retained or used  
27 by the candidate or committee.

1           **§ 3116.       Rule Amendments.**

2           (a)   Petition for Adoption of Rules. Any person may petition the Guam  
3   Election Commission requesting the promulgation, amendment, or repeal of any rule.  
4   Said petition shall be in writing and should fully state reasons and factual basis for  
5   such request. The adoption of any promulgation, amendment, or repeal of any rule  
6   shall be in accordance with the Administrative Adjudication Process stipulated in 5  
7   GCA Chapter 9.

8           (b)   Public Hearing. In the event a petition made is granted, a public hearing  
9   on the matter shall be conducted within thirty (30) days of receipt of such petition as  
10  provided by the Administrative Adjudication Law (5 GCA Chapter 9, Article 3).

11          **Section3.   Adoption.**   The   updated   Guam   Election   Commission  
12   Organizational Report form attached herewith as Exhibit A, the Election  
13   Campaign Contributions and Expenditures Report form attached herewith as  
14   Exhibit B, and the Report of Dissolution form, attached herewith as Exhibit C are  
15   hereby adopted by *ILiheslaturan Guåhan* pursuant to Chapter 17, Title 3, Guam Code  
16   Annotated and Chapter 9, Title 5, Guam Code Annotated, the Administrative  
17   Adjudication Law.

18          **Section 4.   Effective Date.** This Act shall be effective upon enactment.
